

BILLING HYPOTHETICALS

Resident - Normal Accident/Incident:

- LC resident gets in a vehicle collision and requires emergency services.
- Resident determined to be at fault
- City bills his/her insurance
- After insurance there is an outstanding balance.
- The City will NOT balance bill the resident.

Resident – Accident/Incident with Bad Behavior

- LC resident gets in an accident/incident and requires emergency services.
- Resident determined to be at fault
- Resident determined to have acted “recklessly, knowingly or intentionally”
- City bills his/her insurance
- After insurance there is an outstanding balance
- The City SHALL balance bill the resident

Resident – House Fire:

- LC resident has a house fire and requires emergency services.
- City bills his/her insurance
- After insurance there is an outstanding balance.
- The City will NOT balance bill the resident unless it is shown that resident acted recklessly, knowingly or intentionally

Resident – Accident/Incident with No Insurance

- LC resident gets in a vehicle collision/incident and requires emergency services.
- Resident determined to be at fault
- Resident does not have insurance
- The City SHALL bill the resident

LC Company – Accident/Incident by Employee

- LC Company, through its employee, gets in a vehicle collision/incident and requires emergency services.
- LC Company, through its employee, is determined to be at fault
- City bills Company's insurance
- After insurance there is an outstanding balance
- The City SHALL balance bill the LC Company
- If no insurance, City SHALL bill Company directly

Nonresident – Mutual Aid Agreement

- Non-resident gets in a vehicle collision and require emergency services
- Non-resident is determined to be at fault
- LC FD responds outside of LC because of a mutual aid agreement
- Mutual aid agreement does not charge LC residents for services
- City bills non-resident's insurance
- After insurance there is an outstanding balance.
- The City will NOT balance bill the non-resident.

Nonresident – Normal Accident/Incident in League City

- Non-resident gets in a vehicle collision and requires emergency services
- There is no mutual aid agreement in place with non-resident's government entity.
- Non-resident is determined to be at fault
- City bills his/her insurance
- After insurance there is an outstanding balance.
- The City SHALL balance bill the non-resident.

Elevator Rescue

- LC resident or business calls for elevator rescue
- City will bill insurance for the 2nd elevator rescue in a calendar year (January – December)

Helicopter Landing/Takeoff Prep

- If City (Fire Staff) determines that person requires helicopter transport to medical facility based on extent of injuries, City will bill patient's insurance (mostly likely vehicle ins.)
 - Whether to balance bill or not will depend on residency and/or bad actions
- If after transport to medical facility, medical facility staff determine a helicopter is needed to transport patient to specialized facility, Helicopter company usually contacts City (Fire Staff) asking for a helicopter landing site. In such an instance, City will bill helicopter company directly.
