

# REIMBURSABLE AGREEMENT

Gentlemen:

Attached is a copy of a cost estimate dated June 1, 2023, totaling \$979,259.87. This represents ExxonMobil Pipeline Company LLC's (hereon referred to as EMPCo) current best estimate of the costs EMPCo expects to incur to TX-212a must be lowered in two separate locations (hereon referred to as "The Work" to allow your proposed work as detailed in Exhibit "A" across the idled Petrotex Valve-Chocolate Bayou TX-212A in League City, Harris & Galveston County, Texas.

By executing this letter, City of League City, whose address is 300 West Walker St, League City, TX 77573, agrees to reimburse EMPCo 100 percent of the actual cost to accomplish The Work described above and in the attached Exhibit "A". Actual costs consist of but are not limited to: 1) Company Labor, 2) Personal Expenses of Company Employees, 3) Materials, 4) Contact Labor and Equipment, 5) 3rd Party Charges, (6) Administrative Overhead, and (7) Payroll Burden. The established percentages and method of application for these charges are detailed on the estimate attached (form PL-659). By execution of this letter, the City of League City in no way agrees to reimburse EMPCo for any work other than The Work as described above.

Prior to performing The Work, the City of League City must submit a wire transfer or a check made payable to EMPCo for \$979,259.87 to the following lockbox address:

**PLEASE BE CERTAIN THAT YOUR CHECK SHOWS CUSTOMER NO. 493380, TO INSURE PROPER CREDIT.**

Both parties agree that this is only an estimate and that actual costs of the project could exceed this amount. In the event EMPCo determines that the actual costs and expenses for The Work seem reasonably likely to exceed Nine Hundred Seventy-Nine Thousand Two Hundred Fifty-Nine Dollars and Eighty-Seven Cents (\$979,259.87), EMPCo shall cease The Work and promptly notify City of League City, 300 West Walker St., League City, TX 77573. The Work will continue after payment of the estimated overage is received by EMPCo and allocated to the proper project account. Upon completion of The Work, EMPCo shall provide City of League

City with an accounting of the actual costs and expenses incurred in performing The Work, along with reasonable documentation. Should the actual costs and expenses for The Work be less than the estimated cost, the difference shall be refunded to City of League City within 1 year of completion of The Work. Should the actual costs and expenses for The Work be greater than the estimated cost, City of League City shall remit the difference to EMPCo within ninety (90) days of the presentation of an invoice to City of League City by EMPCo showing the actual costs and expenses for The Work.

EXCEPT TO THE EXTENT CAUSED BY THE NEGLIGENCE OF, OR BY THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF CITY OF LEAGUE CITY, ITS CONTRACTORS, AGENTS, OR EMPLOYEES, EMPCO SHALL BE RESPONSIBLE FOR AND HOLD HARMLESS AND INDEMNIFY CITY OF LEAGUE CITY FROM AND AGAINST ALL CLAIMS, DEMANDS, OR CAUSES OF ACTION OF EVERY KIND AND CHARACTER ARISING IN CONNECTION WITH THIS AGREEMENT FOR RELEASE, THREATENED RELEASE, DISCHARGE, CONTROL OR REMOVAL OF POLLUTION, CONTAMINATION, OR ANY OTHER MATERIAL THAT ORIGINATES FROM EMPCO'S PIPELINE OR OPERATIONS OF EMPCO, ITS AGENTS, CONTRACTORS OR EMPLOYEES ON CITY OF LEAGUE CITY PROPERTY. EMPCO SHALL BE LIABLE FOR ANY AND ALL DAMAGES TO THE PERSONAL AND REAL PROPERTY OF CITY OF LEAGUE CITY BY REASON OF EMPCO'S ACTIONS OR OMISSIONS IN CONSTRUCTING, MAINTAINING, REPAIRING, REPLACING, OPERATING, USING OR REMOVING FROM CITY OF LEAGUE CITY 'S PROPERTY THE PIPELINE UNLESS DUE TO THE NEGLIGENCE, GROSS NEGLIGENCE, OR WILLFUL MISCONDUCT OF CITY OF LEAGUE CITY, ITS CONTRACTORS, AGENTS, OR EMPLOYEES. THIS PROVISION SHALL SURVIVE TERMINATION AND EXPIRATION OF THIS AGREEMENT.

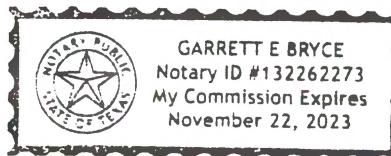

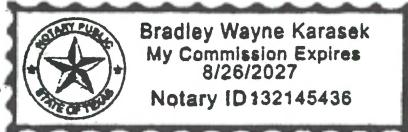

**Exhibit "A"**

**NASA Bypass & Landing Blvd Expansion ROX Conflict**

**Description**

League City proposes to extend both NASA Bypass and Landing Blvd creating a conflict with pipeline TX-212a containing chemical grade propylene. Two proposed areas conflict with pipeline, the NASA Bypass drainage box and Landing Blvd retaining walls.

In order to construct, TX-212a must be lowered in two separate locations represented below in Table 1. Additionally, in both locations load calculations must be conducted for road construction using the proposed depth of coverage (DOC) after line is lowered. Line casing will be recommended should load calculations fail.

Cost estimate for work has been provided based on vendor quotes, matting estimate and engineering scope PRIOR to design review. **Cost may be subject to change depending on stress analysis report if required.**

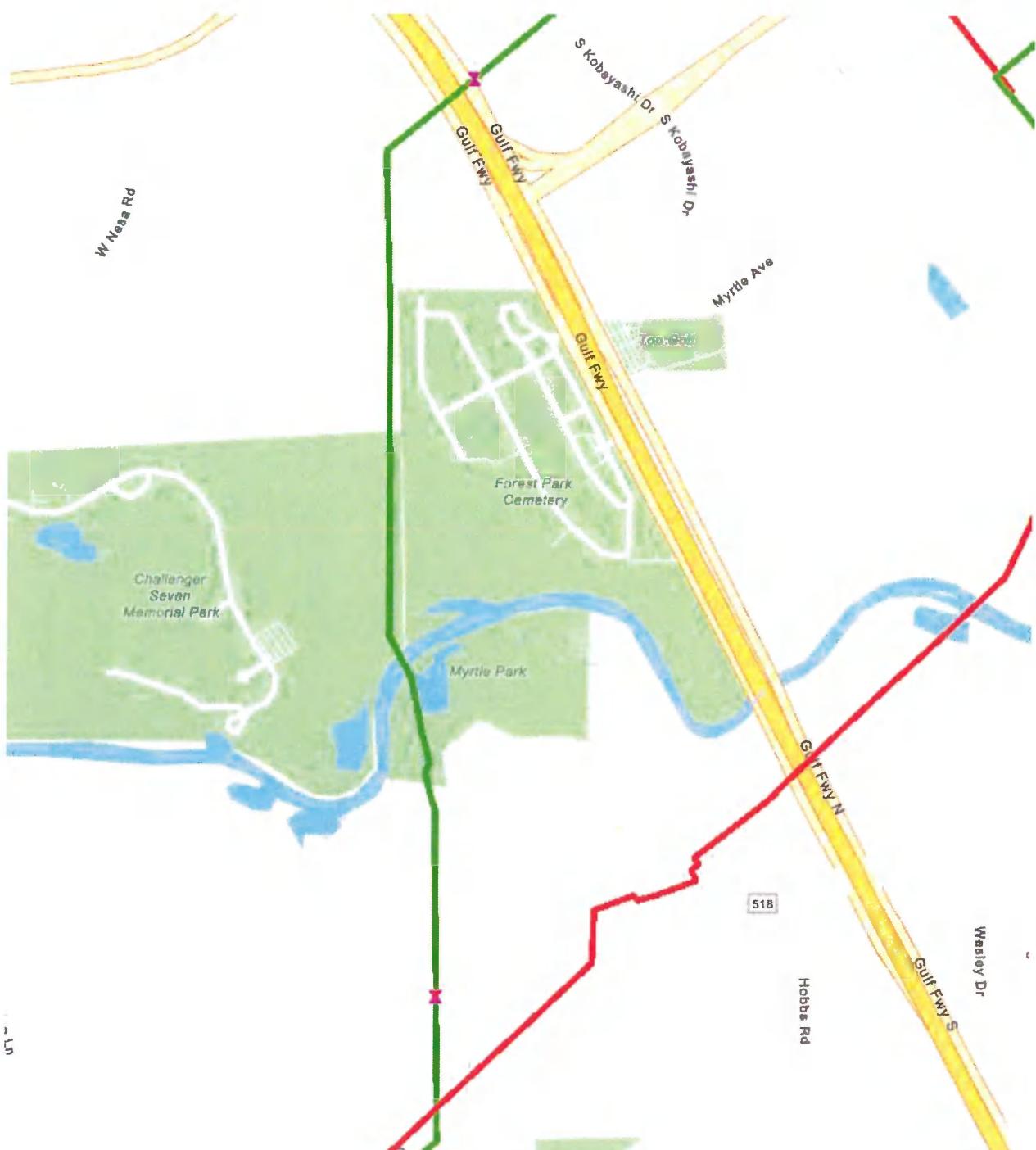

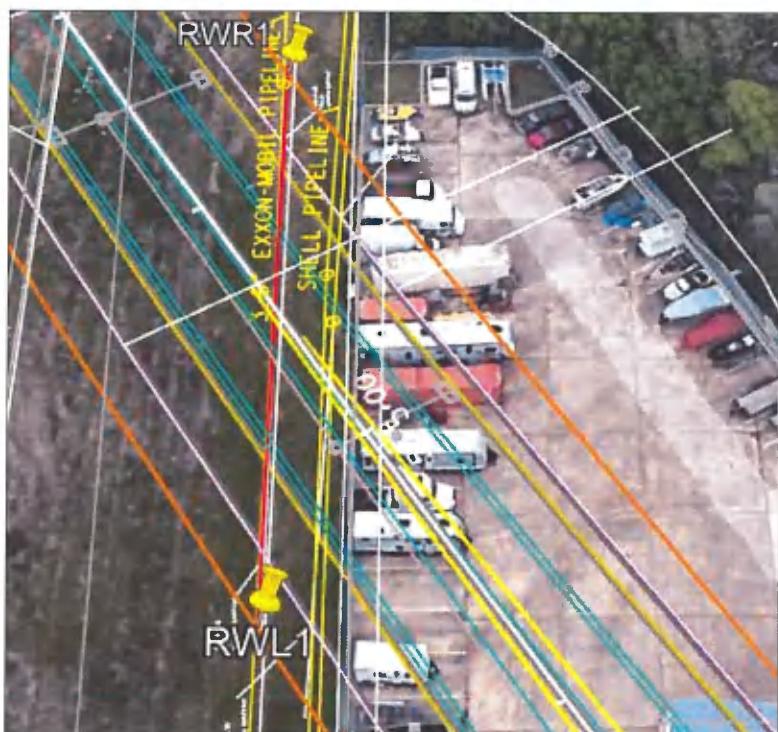


Figure 3. Retaining wall conflict approximately 241 ft. of pipe in conflict.

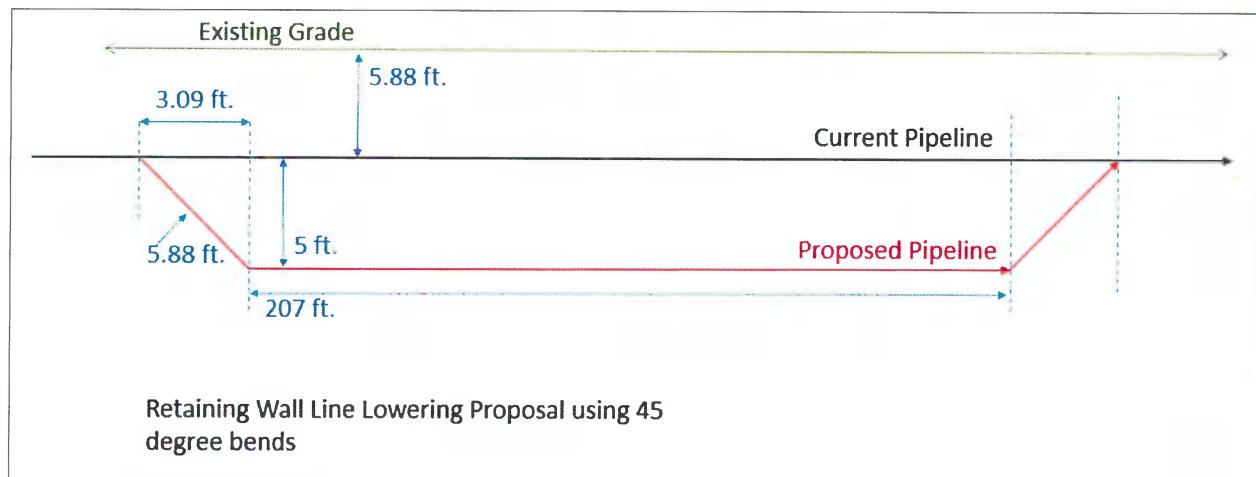


Figure 4. Proposed redlines to lower line below retaining walls conflict.

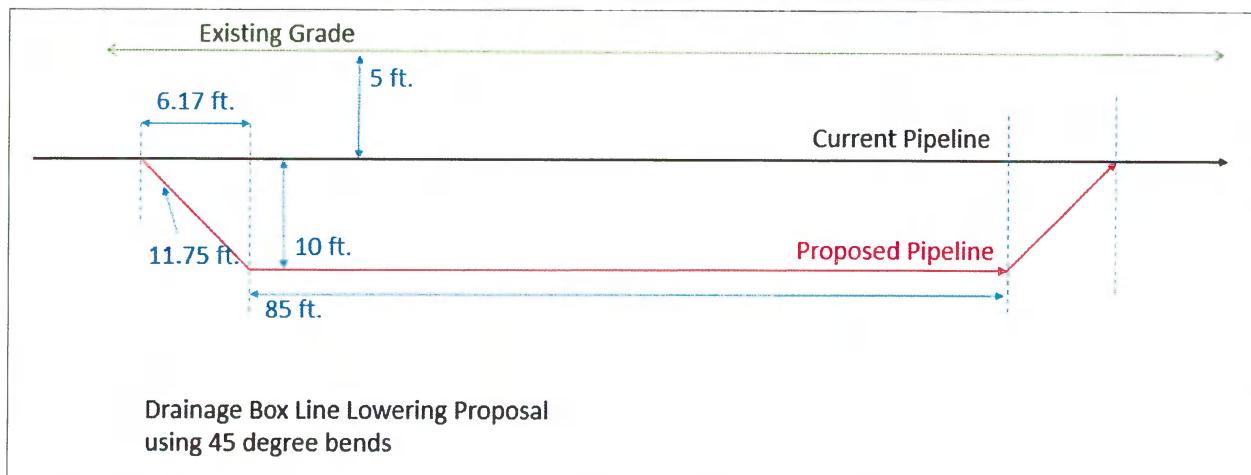


Figure 5. Proposed redlines to lower line below drainage box conflict.
