## ORDINANCE NO. 2024-

## AN ORDINANCE CREATING THE CONFLICTS RESOLUTION PANEL AND APPOINTING MEMBERS THEREOF

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

<u>Section 1.</u> The Conflicts Resolution Panel shall consist of eight (8) board members with the members serving 2-year staggered terms.

<u>Section 2.</u> Upon written request from the Fire Chief or the League City Volunteer Fire Department, Inc. ("VFD"), the Conflicts Resolution Panel shall settle disputes related to:

- 1) changes in the Fire Directorate's and/or the VFD's formalized written polices; or
- 2) an act of discipline administered by the Fire Chief and/or the VFD that includes a reduction of access to city equipment, resources of facilities as contemplated in this Agreement to be made in collaboration.

<u>Section 3.</u> Initial Members Appointed. The following people are initially appointed to the Conflicts Resolution Panel:

Section 4. Savings. All rights and remedies which have accrued in favor of the City under this Ordinance and amendments thereto shall be and are preserved for the benefit of the City.

<u>Section 5.</u> Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid, unconstitutional or otherwise unenforceable by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

<u>Section 6.</u> Repealer. All ordinances and parts of ordinances in conflict herewith are hereby repealed but only to the extent of such conflict.

<u>Section 7.</u> Publication and Effective Date. The City Secretary shall cause this Ordinance, or its caption, to be published in the official newspaper of the City of League City, upon passage of such Ordinance. This Ordinance shall become effective on passage.
