PROJECT DESCRIPTION

The 106-acre park site would serve as a regional park and provide the following for the Western section of League City. A 5-Field Softball Complex and a 4-Field Pony/Colt/Little League Complex (both including restrooms, storage, and concession stands), 2 International-sized Soccer Fields, Tennis Courts/Pickleball Courts, a 9-hole Disc Golf Course, a 5K Trail, Picnic Facilities/Pavilion, 2 Playgrounds, Parking, Lighting, a Maintenance Facility, Utilities, Detention Ponds/Drainage, Landscaping and Irrigation, and 2 to 3 access roads into the park. A TPWD Outdoor Grant will be applied for to fund a portion of this park. The project also includes platting of a Master Plan for the whole park. The addition of these 5 Softball Fields will provide additional recreational facilities for League City Pony-Colt, League City Little League, the Girls' ASA Softball Association, and League City Parks and Recreation, alleviating overcrowding of playing fields by increasing the facilities available for programming needs. The park site is part of a former oil field with potential environmental issues that are currently being assessed and will be remediated if the Texas Railroad Commission determines there is a need. An environmental study is currently underway, anticipated completion of the report is in late 2022, with costs for environmental clean-up included in this CIP project. City 4B Funds will be used for this project and a donation of 13+ acres from the Patrons of the Park will provide the match of \$750,000 for an equal amount from TPWD, if the grant is approved.

PROJECT JUSTIFICATION

The addition of these Ballfield Complexes will allow League City Baseball organizations room to expand their programs and meet the future needs of the community. The other recreational features mentioned in the Project Description above have all been mentioned in the 2017 Parks, Trails and Open Space Master Plan and in subsequent meetings with users. A Texas Parks and Wildlife Department (TPWD) Outdoor Grant of up to \$750,000 is possible for this project and a grant will be applied for by August 2022.
