**PROJECT DESCRIPTION**

This is a project that would renovate the existing FM 270 Public Boat Ramp to accommodate all forms of boats and water craft. The renovation will remove silt from the launch area and reinforce the bulkhead which is at the end of its life. Total cost of the project is estimated at \$821,667. There is potential grant funding through the Texas Parks & Wildlife Department in the amount of \$500,000 for construction. A Boating Access Grant would provide construction funding of 75% from the State of Texas, and the remaining 25% would come from Park Dedication Fees.  
 Construction Estimate: \$666,667 x 0.25=\$166,167 (COLC Match) \$666,667 x 0.75=\$500,000 (State Match)

**PROJECT JUSTIFICATION**

This project is necessary for safety reasons alone. If the Boat Ramp is not renovated soon it will start falling apart and will no longer be usable. The Boat Ramp also needs to be renovated so all forms of boats and water craft can make use of the facility. This is also the only City Boat Ramp in League City. This project is eligible for Texas Parks and Wildlife Department Grant Funding. The deadline for grant application submission is October 1, 2018. All matching funding must be appropriated at the time of the application.
