## Re: Recommendation of Award for League City Kansas Avenue Kayak Launch Project CIP/Project ID No. PK1910A, Project Bid #25-013

On March 11, 2025, at the League City Purchasing Department, three (3) bids were received and publicly read for the above referenced project. The project includes the construction of new elevated walkway, ADA kayak launch, concrete parking with cul-de-sac, sidewalk, and relevant site improvements. A bid tabulation showing the detailed bid results is attached. The apparent low bidder is Jerdon Enterprise, L.P. with a Base Bid of \$1,496,433.50 and Add Alternate bid of \$13,000.00.

Jerdon Enterprise L.P. has demonstrated that they are capable and competent in the construction and installation in similar work, they are currently under contract to construct the City's Dr. Ned & Fay Dudney Clear Creek Nature Center Kayak Launch project and have shown to be a responsive and qualified contractor.

Burditt Consultants LLC recommends that the contract be awarded to Jerdon Enterprise L.P, for the Bid total amount of \$1,496,433.50 plus Add Alternate for a total cost of \$1,509,443.50.
