DRAINAGE DRAINGE EASEMENT

§ KNOW ALL PERSONS BY THESE PRESENTS:

COUNTY OF GALVESTON §

THAT GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 14 ("Grantor"), a body politic and corporate and a governmental agency of the State of Texas organized under the provisions of Article XVI, Section 59, Texas Constitution, whose address is 1300 Post Oak Blvd., Suite 1400, Houston, Texas 77056, for and in consideration of the sum of Ten & No/100 Dollars (\$10.00) and other good and valuable consideration to Grantor in hand paid by GALVESTON COUNTY MANAGEMENT DISTRICT NO. 1, a political subdivision of the State of Texas ("Grantee"), whose address is 1980 Post Oak Boulevard, Suite 1380 Houston, Texas 77056, the receipt and sufficiency of which are hereby acknowledged and confessed, and subject to the conditions and matters set forth below, has GRANTED, SOLD, and CONVEYED, and by these presents does GRANT, SELL, and CONVEY, unto Grantee a non-exclusive rightof-way (the "Easement") for the purpose of conveying storm water from that certain 86.471 acres of land located within the boundaries of Grantee, as described by metes and bounds on Exhibit "A" attached hereto and incorporated herein by this reference for all purposes, on, over and across certain land owned by Grantor, being that certain 0.5110 acres of land (or 22,259 square feet of land) described by metes and bounds on Exhibit "B" (the "Easement Tract") attached hereto and incorporated herein by this reference for all purposes.

Nothing contained herein shall grant or be construed as granting to Grantee the right to use the Easement Tract for any purpose other than for the purposes herein specified or to change the dimensions or location of the Easement Tract.

It is expressly provided that Grantor reserves unto itself, its successors and assigns, all other rights in and to the Easement Tract which do not unreasonably interfere with or prevent the use of the Easement herein granted and conveyed to Grantee.

The Easement hereby granted is non-exclusive, and Grantor, its successors and assigns, shall have the right from time to time to grant further easements over, across, through, and under the Easement Tract for any lawful purpose, provided that the holder of such easement does not unduly or unreasonably interfere with the Easement rights herein granted.

It is additionally provided that this Easement is granted and conveyed subject to any and all matters of public record or existing on the ground, if any such matters do exist and affect the Easement Tract and the Easement rights herein granted and now remain in effect.

It is additional provided that located upon the Easement Tract are certain drainage and detention facilities that were constructed on behalf of Grantor and conveyed to the City of League City, Texas (the "City"), for ownership, operation and maintenance, pursuant to that certain Restated Utility Agreement dated January 22, 1999, as amended, between Grantor and the

City. Notwithstanding anything to the contrary set forth herein, this Easement shall not be effective until the City has consented to this Easement by an instrument executed by the City and recorded in the real property records of Galveston County, Texas. The effective date of this Easement shall be the date of said consent.

TO HAVE AND TO HOLD the above described Easement, together with all and singular the rights and appurtenances thereto in anywise belonging, including all necessary rights of ingress, egress, and regress, unto Grantee, its successors and assigns, forever; and Grantor does hereby bind Grantor and Grantor's successors and assigns to WARRANT AND FOREVER DEFEND, all and singular, the Easement unto Grantee, and its successors, substitutes and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof, subject to all of the terms, conditions, provisions and limitations hereinabove set forth and provided.

Thence, in a Southerly direction, with said curve to the right, having a central angle of 71°49'00", a radius of 90.00 feet, an arc length of 112.81 feet, a chord bearing of S 00°35'36" E and a chord distance of 105.57 feet to a point of tangency;

Thence, S 35°18'53" W, a distance of 663.46 feet to a point of curvature to the left;

Thence, in a Southerly direction, with said curve to the right, having a central angle of 53°40'51", a radius of 110.00 feet, an arc length of 103.06 feet, a chord bearing of S 05°16'10" W and a chord distance of 99.33 feet to a point of tangency;

Thence, S 30°02'09" W, a distance of 210.55 feet to a point of curvature to the left;

Thence, in a Southerly direction, with said curve to the left, having a central angle of 30°32'08", a radius of 745.00 feet, an arc length of 397.04 feet, a chord bearing of S 14°46'06" W and a chord distance of 392.36 feet to a point of tangency;

Thence, S 00°29'58" E, a distance of 47.83 feet, to the Southerly line of said Restricted Reserve "E";

Thence, S 86°11'32" W, along the Southerly line of said Restricted Reserve "E", a distance of 10.02 feet to a point from which a 5/8 inch iron rod with cap for the most Southerly corner of said Restricted Reserve "E", bears S 86°11'32" W, 98.34 feet;

Thence, N 00°29'58" W, a distance of 48.40 feet, to a point of curvature to the right;

Thence, in a Northerly direction, with said curve to the right, having a central angle of 30°32'08", a radius of 755.00 feet, an arc length of 402.37 feet, a chord bearing of N 14°46'06" E and a chord distance of 397.63 feet, to a point of tangency;

Thence, N 30°02'09", a distance of 210.74 feet to a point of curvature to the left;
