SCOPE OF WORK

The project is to remove and replace the erosion control slab under the roadway bridge. It has separated from the bridge/roadway and is sliding down.

Update

Add wing/shoulder to the outer side of the slab under the bridge sloping into the ground in an effort to ensure water is not able to flow under the entire slab thus further preventing the problem in the future.

MATERIALS AND SERVICES NOT INCLUDED

League City will provide the traffic control plan.

PROPOSAL

HOG Construction will remove and replace the existing concrete in its entirety. We will put an 18 inch beam at the top and a 24 inch beam at the bottom. The slab/structure itself shall be 6 inches thick. It will not be tied in to the bridge with rebar as directed. The concrete that is removed will be broken up and used on the inner side of the slab for erosion control. We will construct a wing/shoulder to the outer side sloping into the ground surface in an effort to divert ground water away from the slab.

Our proposal includes all equipment, materials, and labor required to remove the existing concrete and complete all work as required.
