- 1. Augment local and Federal (regular CDBG) funds to construct a sidewalk on the north side of Main Street from IH-45 to the Union Pacific RR tracks. The City has determined the need for this sidewalk through the PY 2023 Annual Action Plan and the Environmental Assessment. HUD has issued strategies to utilize CDBG-CV funds that prepares for, prevents, and responds to coronavirus (known as CDBG-CV tiebacks) as long as the activities meet CDBG national objectives. According to the HUD document, "These [CDBG-CV] funds can also be leveraged to address the causes of community violence and help build stronger, safer, more equitable and ultimately more resilient communities." The CDBG-CV Tiebacks for the inclusion of sidewalk construction with CDBG-CV funds include:
  - Increasing access to outdoor space as an LMA national objective to reduce traffic congestion/improve pedestrian space, and
  - Increasing social connectedness among neighborhood residents to support community revitalization planning and reduce social isolation (a major cause of community violence).

The City intends to use \$202,797.42 of the original \$640,539 in CDBG-CV funds to augment the cost of the construction of the Main St. sidewalk from IH 45 to Union Pacific RR tracks. The original project was a PY 2023 activity which not only was delayed but due to increased costs has exceeded the amount originally budgeted with City funds and CDBG funds. The sidewalk meets the criteria above by:

• 8-feet wide to be ADA compliant and also allow for social distancing;

- Connect the area with the highest LMI population to parks, community center, public services, schools, and amenities including a major pharmacy and medical services, improving social connectedness;
- Links the other major LMA to the east back to the neighborhood in which the new sidewalk will be constructed, providing access to a large park and amenities, also improving social connectedness;
- Builds stronger, safer, more equitable and more resilient communities; and
- Reduces traffic congestion.

The reason for using CDBG-CV funds for a portion of this project is that it not only meets the criteria for a CDBG-CV Tieback, but the need for the originally-intended use of all of the non-administrative CDBG-CV funds has diminished to virtually non-existent. Of the original funds, \$424,741.58 has been expended for emergency rental and/or utility assistance for those affected by COVID, primarily those who lost their jobs or lost hours due to business closures or staff reductions, or who contracted COVID and were out of work or expended available funds on medical care making them unable to pay their rent and utilities. However, at this time there are very few who meet the qualifications for need due to COVID, and those who are in need of rental and/or utility assistance can access regular CDBG funds provided by the City to Interfaith Caring Ministries.

The City abandoned the facility improvements and reallocated the funds to Interfaith Caring Ministries for emergency rent and/or utility assistance. ICM expended \$424,741.58 in assisting residents who were in danger of eviction or utility termination due to the financial need as a result of COVID. By PY 2023, the COVID-related need for such assistance declined to virtually non-existent. Once HUD released documents allowing for COVID tie-backs to be used on sidewalks and the cost of an approved sidewalk had far exceeded the estimated allocation, it was determined that the use of CDBG-CV funds to match existing funds would be beneficial. The sidewalk project ties back to CDBG-CV through
