Geri Bentley said hello and thank you for coming. I would just like to report that I attended this week a combination meeting of TML which is Texas Municipal League and H-GAC which is Houston Galveston Area Council which I'm a member of both of, and talked to some of my fellow city council members and mayors and we are trying to get ahead of what's going to happen in our legislature when it meets next year as far protecting the rights of the cities to be able to make their own rules. The legislature doesn't like when Washington makes the rules that they have to follow, nor do we like rules that are made by the legislature without giving up mandates, without giving us money to do these things. Several of us are going to get together, I'm on a committee at TML to make sure that we protect the rights of our cities.

Keith Gross said good evening and welcome to the City Council meeting. I just want to remind everybody there is a runoff election for County Commissioner. The two candidates are Darrell Apffel and Tim Paulissen. Don't forget to vote. It's an important election.

Nick Long said thank you everybody for coming out tonight. I just wanted to remind you about the League City Music Festival. It's going to be in two weeks. It's the Bellamy Brothers and Clint Black so that's a pretty fun time. Also, congratulations to my alma mater Clear Creek for winning district the third time in a row and knocking out Clear Springs. Awesome.

Mayor Hallisey said a week ago I went to the National Crime Victims' Rights Week Fair that was sponsored by the League City Police Department over in the Civic Center. Chief, I would like you to express to Stephanie, your Crime Victims Advocate, what a great job she did on that fair that she had at the Civic Center. I had a chance to meet all those people that are helping folks in League City. I just absolutely can't believe there are so many people out there trying to step up and particularly help the most vulnerable of us all and that's children, so Stephanie gets a big kudos for putting that together as do you. I want to mention that Richard Lewis has been in the hospital. Richard and his wife take care of the One Room Schoolhouse. He's had a rough go of it. I can't tell you exactly but he is home now so keep him in your prayers. I also want to mention an event of note that happened in Galveston last week. Vandy Anderson died and a lot of us up here may not know who Vandy Anderson was but he was the voice of Galveston. If you rode the ferry you heard him talking. He was the one giving you direction. He was the news man at KGBC, KILE, he was well known through the region, Toastmaster extraordinaire, stood up for everybody, was president of Galveston College. He did a lot of things in the town. Vandy Anderson was a friend of ours. His sister also lives down the street from us. He will be a great loss to all the communities in Galveston County. I want to mention that tomorrow night I'm having a Post Office meeting at 6:30 p.m. at the civic center. This is not our business but true to what I said on the campaign trail, we have people that monitor social media. There are some problems that are taking place at the Post Office. Everybody seems to know about them but me. We're giving people an opportunity to speak directly to the District Manager and the Postmaster. It's not a formal meeting. As I said, it's not our business other than to try to facilitate. Our citizens have a problem and so we're allowing that to go on.

As mentioned earlier, we bypassed some board appointments but I want to make a plea to people in this community that are watching. Please take a look at our website and find the boards and commissions that we have. Government only works as good as citizens that participate and there are a lot of places within League City and its boards and commissions that you can be a part of what's going on. It's an exciting time to be in League City. It's an exciting time to watch what's going on. I'm looking forward to May 10 when Mr. Rohr is going to unveil the downtown revitalization program. We've been hearing about it awhile. We're excited to hear. I think my 41 years here in town, all I've heard about is somebody ought to do something about downtown and improve it and I think that's coming so we'll have a chance to see it. I encourage all League City residents to eat and shop locally. It solidifies our economy. We have business people here in town. Please eat in the restaurants, shop in the shops. There is a resident in town who sent me this purple tie to wear tonight because, as I walk through the halls of City Hall everybody is kind of sobbing over the loss of Prince. I really didn't know Prince's music. I couldn't tell you one song he sang but I know a lot of people loved him and liked what he did so I'm wearing this in his honor this evening. I want to wish luck to all the baseball, soccer and swimming children across League City who are about to begin their summer season. I wish you the best of luck and have a great time.

#### Dan Becker had no comments.

Hank Dugie said I would like to take this time to appreciate a couple of people. Last Friday I was given the opportunity to go and participate in a career fair at League City Elementary hosted by Kaitlyn Thompson who is their Communities in Schools partner. Spending time with their fourth and fifth graders really reinforced my faith in the future. They were some of the most respectful kids. I was standing there in the corner as a city council member and I wasn't too sure how many of them would be interested in coming up and speaking with me when there were professional athletes and police officers in the room but I would say that a fair amount of them came by and they had some pretty good questions so I think we're going to be in good hands one day when they graduate and go off to college and do their part to change the world. I also want to give a shout out to city staff that responded during the tornado that happened just a couple of nights ago. Rumor has it that Mr. Rohr went out there at some point in the evening. Is that true? I would like to give him a round of applause because that's the type of leadership that the city needs. I think when we have emergencies it really goes a long way for the head of the city to be out there and to help out with it, so thank you.

Heidi Hansing said I would like to second the City's responses to all of the rain that we've had over the last week and particularly in that situation with a tornado touch down. Ms. Bentley and I have been invited by a Texas State Senator Bob Hall to a summit this week on Thursday and Friday. We'll be attending and bringing home as much information as we can. What it is going to concern is electric grid security. Here in Texas we have about four-fifths of our electric grid is proprietary to Texas. There's only a small part that is not, therefore Texas has the primary responsibility to protect the electric grid, unlike the other states which are going to be reliant on a national response Texas can actually do something about it.

The critical security concerns that we're going to be discussing are high impact threats that would cause a critical infrastructure collapse for a month or more. If you remember from Ike when just a little bit north of here some of the cities were without electricity for weeks and even into a month or two. Civilization breaks down pretty quickly when people are without electrical power. We're going to be addressing specifically Texas' electric grids vulnerability to electromagnetic pulse, geomagnetic solar storms and cyber attacks. Also, we will be discussing emergency preparedness and emerging protective technologies and will highlight local state and federal legislative protection and security efforts. I'm looking forward to that. There's going to be quite a stock of experts there and we're going to be there to learn as much as we can and bring it back here to League City.
