AMENDMENT TO INTERLOCAL AGREEMENT

This AMENDMENT TO INTERLOCAL AGREEMENT (this "Amendment") is made and entered into and between, and among COUNTY OF GALVESTON, TEXAS ("COUNTY"), the CITY OF LEAGUE CITY ("CITY"), and REINVESTMENT ZONE NO. TWO, CITY OF LEAGUE CITY, TEXAS ("TIRZ 2"), collectively referred to as the "Parties":

RECITALS

WHEREAS, the Parties entered into a Interlocal Agreement (the "Agreement"), in connection with the implementation of TIRZ 2's Project Plan, setting forth the participation by COUNTY with respect to the tax increment generated by CCISD to be deposited in the TIRZ 2 Tax Increment Fund; and

WHEREAS, the TIRZ 2 Project Plan has been fully implemented and there is no need for further contributions into the TIRZ 2 tax increment fund by COUNTY; and

WHEREAS, the parties wish to terminate the Agreement;

NOW THEREFORE, it is mutually agreed by the Parties as follows:

TERMS

1. Recitals. The aforementioned-recitals are true and correct and hereby incorporated into this Amendment.
2. Definitions. Capitalized terms used in this Amendment, and in the recitals hereto, shall have the meanings provided for them in the Agreement, unless otherwise defined, or the context clearly requires otherwise.
3. Tax Increment Participation by COUNTY Terminated. The Parties agree that COUNTY shall cease making any contributions into the TIRZ 2 Tax Increment Fund after December 31, 2016 and the Agreement is hereby terminated effective December 31, 2016.
4. Cooperation. The Parties agree to cooperate as may be reasonably necessary to implement the terms of this Amendment, including notification of the Galveston County Appraisal District regarding the termination of the participation of COUNTY in TIRZ 2.

IN WITNESS HEREOF, the parties make and execute this Amendment in multiple copies, each of which is an original, to be effective as of December 31, 2015.
