- 1 LUC will mobilize to the job site secure area plug and secure incoming lines and set up a temporally bypass from one manhole upstream in to headwall
- 2 LUC planning on walking a Minnie excavator down to the bottom up to head wall for lifting and handling of equipment and materials
- 3 LUC will built a temporally water dam (bulkhead) using a on site buildable aluminum box and dewater the include area with a 4" or 6" submergible pump (Hydraulic or Electric)
- 4 Clean and To Inspect the existing line to determined if any additional repairs to be made prior to slipline also to determine what size be the proper size to slipline
- 5 Slipline will be performed with the nearest size possible to a 24"IPS HDPE SDR 26 depending on deflection and defect in the existing line 22" or 20" IPS pipe is also available
- 6 after slip lining is completed both ends will be seal and annular space will be grouted

1	This work to be schedule for the mid to late part of January 2017 due to holidays season and commitments in hand.
2	Some debris will be flowing out to the water front it may be very little LUC can do to contained and haul off
