

**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE CITY OF LEAGUE CITY AND RPS KLOTZ ASSOCIATES**

This First Amendment (“Amendment”) is entered into between the City of League City (“City”) and RPS Klotz Associates (“Professional”) on the date set forth below.

RECITALS

WHEREAS, the City and Professional entered into an Agreement (“Agreement”) on April 24, 2014 whereby Professional agreed to provide professional design services related to the completion of the Five Corners Realignment Project (the “Project”) and the Agreement is incorporated into this Amendment by reference; and

WHEREAS, on March 2, 2015, Professional changed its name from Klotz Associates Inc. to RPS Klotz Associates when RPS purchased all the assets of Klotz Associates, Inc.; and

WHEREAS, on May 19, 2015, the City authorized Professional to provide additional services by designing a multi-use path for the Project (“Supplemental #1”) in an amount not to exceed \$49,933.75 and Supplemental #1 is incorporated into this Amendment by reference.; and

WHEREAS, the City wishes to further amend the Agreement 1) to revise the construction plans to reconcile the differences between the City’s and TxDOT’s datum and provide construction phase services (“Supplement #2”) and 2) revise the construction plans to improve traffic movement efficiency (“Supplement #3”); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree to the following terms:

TERMS

1. The above-listed recitals are true and correct and hereby incorporated into this Amendment.
2. The Professional is authorized to provide the additional services identified as identified in Supplement #2, which is attached and incorporated as Exhibit A for an amount not to exceed \$49,883.75 and as identified in Supplement #3, which is attached and incorporated as Exhibit B, for an amount not to exceed \$29,443.75.
