I think that was a huge plus just to let everybody come out and talk. I do want to say a little about the council retreat. I thought it was fantastic. I really learned a lot about my fellow councilmen here and I think it was very positive. Last, the League City Lion's Senior Breakfast is this Sunday morning at 7:30 a.m. Bring the seniors out and come for a free breakfast. That's it. Thank you.

Mayor Hallisey said Janice and I had a great opportunity last Friday night. We were made the Honorary Chairmen for the Krew of Babalou in the Mardi Gras. I always wanted to be on the third story of a float. I'm here to tell you that throwing beads is not an easy chore. It's a young person's sport but we had a blast and we met a lot of new people and it was great fun. We also had an opportunity to throw more beads the second night at a balcony party with some friends, so we had a great time. I want to remind everybody that on March 11, the Senior Citizens Fun Run and Walk 1.5 and 5K is taking place. I want to encourage, not just seniors but anybody to come down there and participate with those folks. I'm always reminded of what they do. I remember them dancing in Janice's Holiday in the Park Parade. They've got a lot life in them with they get to my age. I also had a great time calling bingo with the senior citizens at Hometown Heroes Park. That doesn't sound like a big deal but there are a lot of great people down there that have smiles on their faces, they're happy and they see the good things around town. I met on Wednesday night with the Brittany Bay Homeowners Association.
