## 8. <u>COMMENTS/REPORTS FROM MEMBERS OF COUNCIL</u>

Announcements concerning items of community interest. No action will be taken or discussed.

Mayor Pro Tem Todd Kinsey said I want to thank Mr. Gripon for facilitating the meet and greet we had with the City of Webster. It was a really good time, surpassed my expectations. The evening was extremely well attended. There had to be at least 50 people, really enjoyed getting to know a lot more of their staff and elected officials. That was a great time. Mr. Gripon is the one responsible for getting the ball rolling. At the Library the next couple of weeks, on Thursday, July 27, The Texas A&M Chemistry Road Show will appear at the Johnnie Arolfo Civic Center from 10:15 to 11:15 a.m. This activity is most appropriate for children grades K-5, who will learn through safe and visual demonstrations that chemistry can be both exciting and fun! Irene B. Walters, of the Clayton Library Center for Genealogical Research, presents "Genealogy Tips and Tricks: Finding Ancestors by NOT Searching the Known Information." This event will be held in the theater on Monday, July 31 from 6-7:00 p.m. Participants are welcome to bring tablets and laptops. The Antiques Round Table meets in the Board room at 1:00 p.m. on Monday, August 7. The topic for this week is Early American Portraits, and it will be presented by Mary Opascar.

Hank Dugie said thank you, everyone, for being here tonight and for those of you watching from home. Government works best when citizens participate and provide input. So we really do appreciate all of you being here and speaking on matters that are important to you. I'm happy to announce that I made it back safely from Haiti. It was a great trip, I got some sun. I think we were able to have an impact in the native Haitian people's lives as well as the people who were on the trip. I think we were impacted probably just as much, if not more than the people we were going there to serve. Probably the biggest thing I picked up during my time was that there is great need in the world. When we look around League City and we live our lives on a daily basis, we have our individual struggles and hardships, but we have everything that we need. There are people around the world that don't have the basic necessities, they don't have clothing and water and food. So it really opens my eyes to real need. On that note, they were some of the most true risk people I've ever met. It just goes to show that you don't need much to be happy. You just need family, friends, community and a purpose. Keep that in mind as you go about your week this week and again, thank you all for being here.

Larry Millican had no comments.

Greg Gripon said recently I did some landscaping for the Mayor of Webster, Donna Rogers, and we got into a discussion about our two cities never really getting together. I thought that was something that would be really important for our two councils to do a meet and greet. She took it upon herself to host it and have us all out, but she also included the wives and she included the directors in the city. It was a really great meet and greet for all of us to get together and be able to talk and share our interests and share how we can work together. Looks like League City will probably be hosting the next one next year. Also, our League City Lions Club, our monthly senior breakfast will be coming up on August 6 at Hometown Heroes Park. League City Police Department is hosting a blood drive this Friday from 8:30 to 11:30 and don't forget your free beach towel as a thank you. So if you give blood at the Police Department you'll get a beach towel.

Nick Long said thanks for everybody coming out tonight. Last night we had a big discussion about the budget and that kind of dovetails into what Mr. Bowen said. I would say that not everybody on Council feels, or is opposing the property tax caps. I, for one, am completely in support of the Governor's idea to cap property tax gains. We have not had that problem here in League City. For the last four years, five years, we've experienced these soaring appraisals, but the City of League City itself has brought the tax rate down to account for those soaring appraisals. However, if you look across the state, it simply isn't happening. A lot of cities are taking advantage of the rising appraisals and just saying we're not raising the tax rate, but then reaping the benefit of all this money coming in. So once again we experience large appraisal increases across the county, and particularly in League City. Once again, thanks to the staff, they presented us a budget that will get us down near the effective rate, so essentially on average people would pay about what they paid last year. So we're still working through the budget, but we've taken proactive steps to make sure that while the appraisals keep going up, the actual dollars that you pay out of your pocket really won't go up as well. So we're working through the process, but I think everybody up here has been diligent and especially the staff to not just run out and try to grab all the cash that was thrown at us from the CAD.

Dan Becker had no comments.

Mayor Pat Hallisev said I want to start with, I announced at the meeting after June 5 that we had lost a former councilman here in town, James Davis, and his wife Nancy Guthrie and his daughter Kelly Boyd are here tonight. They had called for James' service and asked me if I'd do a proclamation, which I was happy to do. James was a friend of mine for well over 40 years. There's not a building in this complex that when you look at the plaque on the corner that you don't see the name J.W. Davis. He came along through this town, showed some great strength. There's an old funny story about it, that he and Johnnie Arolfo used to joke back and forth about this facility, before it was built, would accommodate a city of 50,000. And people scoffed at them, they laughed at them. They thought they were being clownish about it, that the city would never be 50,000. It got to be about 1995, we were passing 50,000 and here we are 2017 passing 103,000, so it far exceeded their expectations. In the proclamation I'm going to tell you some stuff about James, but he was, along with Jack Rowe, the Village Fair here in town. That was before Greg Gripon and his son were even born. They put the Village Fair on the map, biggest two-day fair in Texas. James sold real estate, he built houses, he sold insurance, he did a lot of things. But for his friends it was a big loss to know that he was gone. I had just seen he and Nancy out at dinner at the country club, I think maybe a year or so ago. He looked great, he looked happy and things were going good. He'll be missed. I've already presented this proclamation to them, this is kind of a throwdown, but I'm going to give it to you anyway. (Mayor Hallisey read the proclamation.)

Mayor Hallisey continued, thanks everybody for being here. I know you could be a lot of different places tonight. We're happy that you're here. I want to echo Councilman Gripon's comments about the City of Webster. It was a bold move on their part, and I'm glad Greg initiated that, to invite us over for dinner. One of the things that happens as you get bigger you get busy and you don't pay attention to your neighbors nearly as much as you should. In this county and in this Clear Lake area, we need one another to be able to move forward on economic development projects, legislative projects. Thanks, Mayor Rogers, I thought that was a bold move, a great move. We had a good number of the Council and staff there. The food was great, our guys kind of settled out at the golf course and they were trying to beat each other at Top Golf. Some of us sat back and watched. Mr. Millican, did you take a swing at the ball, but your wife took a swing at it. She was good. I think Greg mentioned it, but the Police Department blood drive, if you are able to give blood, please do. There are a lot of folks who need blood, please do it. Mr. Bowen, I want to say one thing about the property tax, I'm not against the property tax.

Whatever we set a tax rate at you can remove us if you think it's too bad one way or the other. What I take exception to is, local control is best control and if you want Austin running your business down here, we're going to debate later this evening about drilling because of House Bill 40. The State preempted us making any decisions on oil drilling in our own community. I would argue with anyone that us having a word in that or having a legitimate say is appropriate. But they took that away from us and we have been to every state agency, we don't get answers to questions and I suspect that as the state moves to control tax limits and every other thing, we'll have the same problems. The State of Texas gave cities the opportunity to determine their own futures within State Law and within Federal Law. That's what I'm opposed to and I think the legislature is overstepping its bounds of control and has done nothing that I can see but cause problems for us. If you think we raise taxes too much, and we're a 25-year city of dropping our rates, proportionally to try to balance out the appraisals, we've done pretty good at it. Let me give you an example. If we get hit with another Ike, if we reduce our fund balances to take care of people in this town, we run out of money, what they'd like us to do is to go to a vote when people need help immediately. I still think that local control is the best control and I think you won't find anybody in Texas who will argue that taxes need to go down. That's a given. We're trying to do it as cheaply as we can, but I think we're doing a pretty darn good job of it in this city. In fact, every city in this county and obviously from the response across the state of Texas, most cities feel the same way. They know that if you don't like what we do, you can replace us every 2, 3 or 4 year, whatever the term being. I just want to straighten it out, it's really not about taxation, that's the buzzword that the press gives it. It's about local control. That's what it's about. You don't have to agree, that's just my take on it. There are 11 students from the League City area who attend Clear Falls, Clear Springs, Clear Creek High Schools that are participating in the Water Polo Junior Olympics in Orange County, California. The boys are competing July 20-25 and the girls from July 25-31. They are part of when schools not is session, it's called club teams. They are associated with the West Houston Water Polo program and their club team is the Viper Pigeons. We wish them the best of luck and hope they come back victorious and make all League City Proud. Good luck to the guys.
