Gary,

In light of last night's budget discussion and a general consensus of establishing a tax rate at \$0.55 we need to make some decisions on what to push forward from the desired but unfunded list to include in the budget ordinance going forward to Council on August 21/22. The additional revenue going from \$0.542 to \$0.55 is approximately \$550,000. Is it possible to add the 1/2 ambulance

safely and reliably by using our 5 ambulances and not adding the additional box?

If possible we could add the air packs, the ambulance crew at 7 days a week 12 hours a day, and possibly the additional dispatch help and pool maintenance.
