

ORDINANCE NO. 2017-

AN ORDINANCE AMENDING ORDINANCE NO. 2005-24 TO REZONE APPROXIMATELY 1.19 ACRES (**MAP-17-0001 BAY VIEW SECTION 4**) FROM “OS” (OPEN SPACE) TO “RSF-5” (SINGLE-FAMILY RESIDENTIAL WITH A MINIMUM LOT SIZE OF 5,000 SQUARE FEET), LEGALLY DESCRIBED AS ALL OF LOTS 10, 11, AND 12, AND A PORTION OF LOTS 8, 9, 13, AND 14, BLOCK 2, BAY VIEW SECTION 4, GENERALLY LOCATED EAST OF CALDER ROAD, ALONG DALE RIDGE LANE, TERRACE CLIFF LANE, AND ROLLING CREEK LANE, WITH THE ADDRESSES OF 260 AND 262 DALE RIDGE LANE, 3015 AND 3013 TERRACE CLIFF LANE, AND 265, 263, AND 261 ROLLING CREEK LANE IN CITY OF LEAGUE CITY, TEXAS.

WHEREAS, at the May 1, 1999 General Election the qualified voters of the City of League City voted that staff proceed with the concept of zoning for the City; and

WHEREAS, on August 10, 1999, the City Council of the City of League City, Texas (the “Council”) adopted Ordinance No. 99-52 amending the Code of Ordinances of the City of League City to add Chapter 125 regarding zoning; and

WHEREAS, on August 30, 2005, the City Council adopted Ordinance No. 2005-24 amending Chapter 125 of the Code of Ordinances of the City of League City and adopting zoning ordinances consistent with the Comprehensive Plan for the City of League City, Texas; and

WHEREAS, Chapter 125, Section 125-49 of the Code of Ordinances establishes a procedure for a property owner, his authorized agent, or the City Planner to request zoning changes; and

WHEREAS, the City Council considered the recommendation of the Planning and Zoning Commission and duly conducted a public hearing as required by law; and

WHEREAS, the City Council deems it necessary and in the best interest of the citizens to rezone approximately 1.19 acres from “OS” to “RSF-5”, legally described as all of Lots 10, 11, and 12, and a portion of Lots 8, 9, 13, and 14, Block 2, Bay View Section 4, generally located east of Calder Road, along Dale Ridge Lane, Terrace Cliff Lane, and Rolling Creek Lane, with the addresses of 260 and 262 Dale Ridge Lane, 3015 and 3013 Terrace Cliff Lane, and 265, 263, and 261 Rolling Creek Lane in League City, Texas as shown in the attached Zoning Map in Exhibit “A” and in the attached platted subdivision being the Bay View Section 4 Subdivision according to the Galveston County Clerk’s File Number 2017008324 of the records of Galveston County, Texas in Exhibit “B”;

NOW, THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, that:

Section 1. The facts and opinions in the preamble of this ordinance are true and correct.

Section 2. The approximate 1.19 acres, legally described as all of Lots 10, 11, and 12, and a portion of Lots 8, 9, 13, and 14, Block 2, Bay View Section 4, generally located east of Calder Road, along Dale Ridge Lane, Terrace Cliff Lane, and Rolling Creek Lane, with the addresses of 260 and 262 Dale Ridge Lane, 3015 and 3013 Terrace Cliff Lane, and 265, 263, and 261 Rolling Creek Lane in League City, Texas as shown in the attached Zoning Map in Exhibit “A” and in the

attached platted subdivision being the Bay View Section 4 Subdivision according to the Galveston County Clerk's File Number 2017008324 of the records of Galveston County, Texas in Exhibit "B"; shall heretofore be zoned "RSF-5".

Section 3. All ordinances and agreements and parts of ordinances and agreements in conflict herewith are hereby repealed to the extent of the conflict only.
