

FOURTH ADDENDUM TO
CITY OF LEAGUE CITY
COMMERCIAL AND RESIDENTIAL
SOLID WASTE AND RECYCLING AGREEMENT

This Fourth Addendum to Commercial and Residential Solid Waste and Recycling Agreement is made and entered into as of _____, by and between the City of League City (hereinafter "CITY"), and BFI Waste Services of Texas, LP (dba Republic Services) (hereinafter "CONTRACTOR") with an effective date of _____.

WHEREAS, on October 26, 2012, CITY and CONTRACTOR entered into that certain Commercial and Residential Solid Waste and Recycling Agreement (hereinafter "Agreement") whereby CONTRACTOR has agreed to provide, and CITY has agreed to accept the performance of solid waste collection and disposal services for CITY pursuant to the terms and conditions set forth in the Agreement; and

WHEREAS, on December 11, 2012, CITY and CONTRACTOR entered into an addendum (First Addendum) whereby the parties agreed and finalized on the pricing and fees (Exhibit B) for the Agreement; and

WHEREAS, on January 14, 2014, CITY and CONTRACTOR entered into another addendum (Second Addendum) that updated the pricing and fees (Exhibit B) for the Agreement; and

WHEREAS, on December 4, 2014, CITY and CONTRACTOR entered into another addendum (Third Addendum) that added language to the Agreement which addressed performance requirements and provided for penalties arising from any performance deficiencies; and

WHEREAS, CITY and CONTRACTOR wish to further amend the Agreement to extend the term of the Agreement from January 31, 2018 to _____ and to update the pricing and Fees (Exhibit B) for the Agreement during the extended term.

NOW, THEREFORE, for good and valuable consideration, CITY and CONTRACTOR agree to the following:

1. The above-listed recitals are true and correct and hereby incorporated into this Fourth Addendum.
2. The ending date of the Agreement is extended from January 31, 2018 to _____.
3. The document entitled Exhibit "B-1 – Pricing and Fees", which is attached and incorporated herein shall be incorporated into the Agreement.
4. Except as expressly provided in this Amendment, all other terms, conditions and provisions of the Agreement shall continue in full force and effect as provided therein.
