Mayor Hallisey called the meeting to order at 6:00 p.m. and called the roll. All members of Council were present with Nick Long attending by videoconference call.

4A. 18-0168 Presentation by the TIRZ #2 (Victory Lakes) and TIRZ #4 (Westwood) Boards (Director of Finance)

David Hawes gave an introduction, Scott Bean presented. TIRZ No. 2 was created in 1999 to assist with the public infrastructure costs in the Victory Lakes subdivision. The city, county and school district contribute their ad valorem tax dollars on the increase in taxable value from the development toward the construction of Walker Road and other roadways and utilities. City participates at 100%. To date the city has contributed \$14,463,876. It is estimated that all obligations and projects will be complete by FY2020 and the TIRZ be dissolved.

David Hawes presented TIRZ No. 4, was created in 2003 and recreated in 2006 to assist with construction of Maple Leaf Drive and League City Parkway, two major thoroughfares adjacent to and through the new Westwood subdivision. The TIRZ also pays for regional detention. The city and county contribute their ad valorem tax dollars. The City participates at 75%.

Announcements concerning items of community interest. No action will be taken or discussed.

Mayor Pro Tem Todd Kinsey said I will be very brief. Just real quick going on at the Library, their new ESL conversation group meets on Mondays at 6:30 p.m. and Wednesdays at 10:30 a.m. in the Board Room. This group is for native speakers of any language who wish to sharpen their English conversation skills. Teens interested in summer volunteering may pick up applications beginning May 1. Applicants will then be notified regarding training and orientation. Finally, the League City Book Club will be discussing E.L. Doctorow's story "Wakefield" and they'll also be screening the movie. That will be on April 16 from 7:00 p.m. to 8:00 p.m. The discussion and then the movie will be seen at 10:00 a.m. on Saturday, April 14. Everybody have a great week.

Larry Millican said just real quick, I thank everybody for coming. I appreciate, very much, the attendance and everybody at home. I wanted to remind everybody that the State of Texas is having their Regional Transportation Plan and we have an opportunity as Galveston County to participate in that in a public meeting. It'll be held in two weeks at the Helen Hall Library and I urge everybody to attend that doesn't want to come back to the council meeting. I can't attend because I'll be here in this meeting but it will be held and it will be an excellent opportunity to see what the whole region has for traffic and where they're thinking that we're going to be going in the state of Texas in this region and also offer your input as far as if you are satisfied with the traffic that is in the region. At any rate, I urge everybody to go that has the ability to go. Thank you.

Greg Gripon said what a beautiful day we had today. These are the type of days you just love in League City. I just want to say that our council staff planning retreat was a huge success. A lot of great things came out of it. I will keep this short. Justin did forget to tell you there's posters up at the front so take some home, put them up, get them out and let everybody know. I'm now being told the posters are not up front. I guess they went with him. We'll get you some posters.

Mayor Pat Hallisey said Mr. Millican is older than I am, and I am just following suit with him. A couple of things, we spent all day down here Saturday going through a strategic planning exercise. I thought it was productive. I think there is one underlying thing, priorities may have changed a little bit, but we are one growing community and we have a lot of challenges in front of us. One of them of course is drainage. I think everybody recognizes that. I'm proud of John because within a couple of days of the storm, he had started on a process to get seven neighborhoods, getting engineering done on seven neighborhoods.

I can tell you that I know that everybody would like to say the animal shelter will solve your problem but I have to tell you, by the time we get the data in and we decide what course of action we can take, it's going to take a while to muster the money to do the things that seven neighborhoods want done. We also had the county in our office the other day, talking about what they're doing on Gum Bayou so they are starting at the back end and they will be working up towards you and we were all a little surprised at Chris Stevens walk down Gum Bayou. It was probably the first time in a while some of us have had a good view of that bayou all the way down to FM 646 and on to Dickinson Bayou. We could fix every drainage problem that there is and vet we're not guaranteed or every neighborhood drainage problem that there is, and I'm not sure that we are afforded of the luxury of saying that we've done it all because until we figure out how to deal with Dickinson Bayou and Clear Creek, which are both subject to tidal flows, no matter how many ditches we build, no matter how many storm sewers we clear out, until we can get a more regional approach to what to do about that, I'm not sure that we're going to, we're talking about gaining a mile, I don't know that we will do that. I'm proud of John because I think he's taking a measured approach to this. I think seven engineering studies within the first couple of weeks after the storm is pretty remarkable on our staffs' part. Figuring out how we're going to pay for any of the things that are going to be recommended to us will be the second challenge that will come from this. I think that we have finished two engineering studies and we're expecting the third one shortly but that's still another four to go and to try to put that into a comprehensive plan, let me tell you, every neighborhood thinks theirs was destroyed worse than the other. There is no perfect answer to it but getting started on drainage issues and moving it considerably up the priority list is happening as we speak and will continue to happen. I know it's easy to reach out and pick at another project and say that's not worth doing but in three, four, five, or six years of waiting for that to get done and other things that are on our list, drainage is certainly moved up. We are a sophisticated city with \$200 million for the things that have to get done next year and we're just now starting to think about where we begin with that now that the storm is over and people have had the opportunity to kind of sit back and say how do we go about solving these problems. It probably will never happen as fast as any neighborhood wants it It's going to happen. to happen but I doubt seriously that anybody within this institution is going to drag their feet on public safety, no matter how you slice the pie. So anyway, I thought we made a really good shot at getting all the staff and all the council members, for probably the first time ever if not in a long time, to come together to talk about what's in front of us and believe me, it's a daunting task and nobody is ducking that up here, so when you come and you tell us that your neighborhood is pretty important, we agree with you. I can tell you that every one of my neighbors where I live are just the same and they don't miss an opportunity to tell me every time they see me, when everybody was flooded down along that creek. And all those people that live in the Oaks of Clear Creek that were devastated don't miss an opportunity to tell us how important they are and we agree with everything that everybody is saving. Everybody is important.

Coming up with a plan of how to approach this, and I hope that all of you are still here with us when the only way we can pay for this, is to come out and ask for you for a sizable tax increase because what we're looking at certainly exceeds well-over, just for Bayridge alone is probably \$20 million worth of work that has to be done. \$20 million to us is somewhere between 10 and 15 cents on the rate. At the end of the day, it comes down to how much money we have to spend and how much you're willing to spend to get all this done. It's not something that you can just pull a rabbit out of the hat. We got hit hard. We got hit harder than we have ever been hit in the history of this town and we're making every effort meeting every challenge that comes at us trying to come up with a reasonable way to get going forward. Just remember that at the end of the day, all of this costs money and the problem is so big, it's not a matter of priorities, it's not a matter of what you're going to do without, because all of you for the most part, you don't want us to cut policemen because you want to feel safe in your neighborhoods, and you don't want us to cut firemen because when your house catches on fire, you expect that somebody will show up to put it out. I'm not picking at anyone and I'm not making fun of anyone, I'm just trying to express to you, the daunting nature of the task in front of us and I think everyone at this table is taking it serious, as serious as a heart attack. That gave me a pain.
