Replacement and/or upgrade to Park Facilities for Energy Efficiency and Beautification:
 FY18: Re- Plaster of Municipal Pool on the Walker Complex to include removal/haul away of all layers of old plaster, replacement of both lane and water lines. \$80k
 Burd House/ Park Administration Office Exterior Renovation at League Park to include removal and disposal of lead based paint materials in mandated fashion, replace any rotten wood, re-glazing of old window panes, prepare surfaces and repaint with exterior grade primer/ paint to color match existing. \$130k
 Rehabilitation of Fly Ash Aggregate Trail at Nature Center to include repurposing /regrading of old materials on site to be used as a sub base with installation of new 6' wide trail material consisting of permeable decomposed granite with stabilizing bonding agent and 6" drainage pipes installed where needed for rain water sheet flow beneath the trail. \$125k
