Re: H-GAC TIP Application for FM 270 Reconstruction and Widening

Mr. Clark:

The City of League City has identified the reconstruction and widening of FM 270 from FM 518 to FM 646 as a local priority. In general, the City lacks sufficient north/south capacity and considers improvements to FM 270 critical to meeting future population and economic growth. The City is preparing a Transportation Improvement Program (TIP) application for the H-GAC call-for-projects to request \$21.5 (\$2018) for construction and TxDOT administrative oversight.

This letter is to confirm that the City has conferred with TxDOT regarding the agency's participation if the project is awarded funding. The City is prepared to proceed with design and environmental review and all other information necessary for the TIP submittal as a demonstration of its commitment to the project. The City has also resolved to provide 20 percent of the construction cost. If awarded funding, this letter is to inform you that TxDOT agrees to let the project.

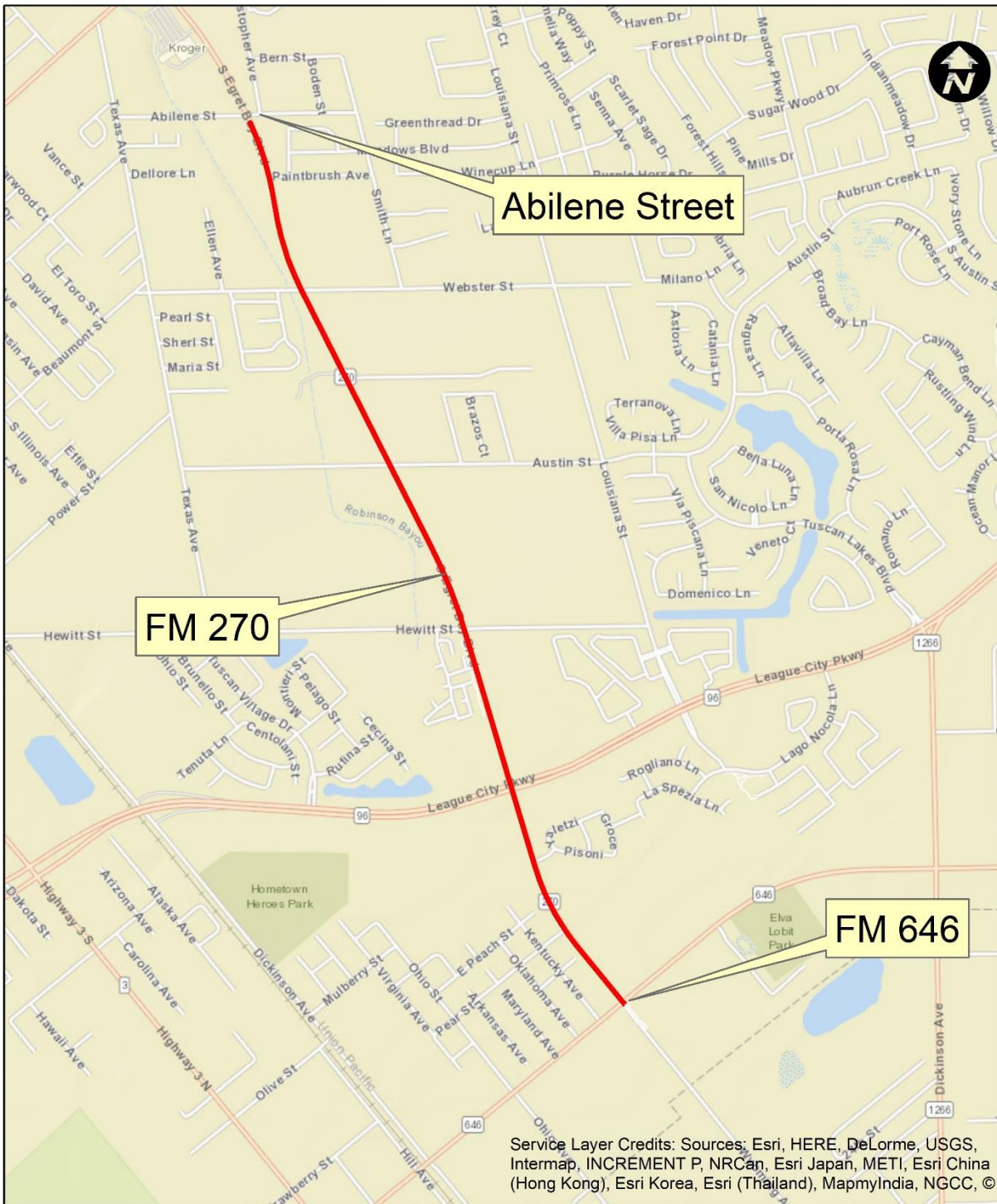

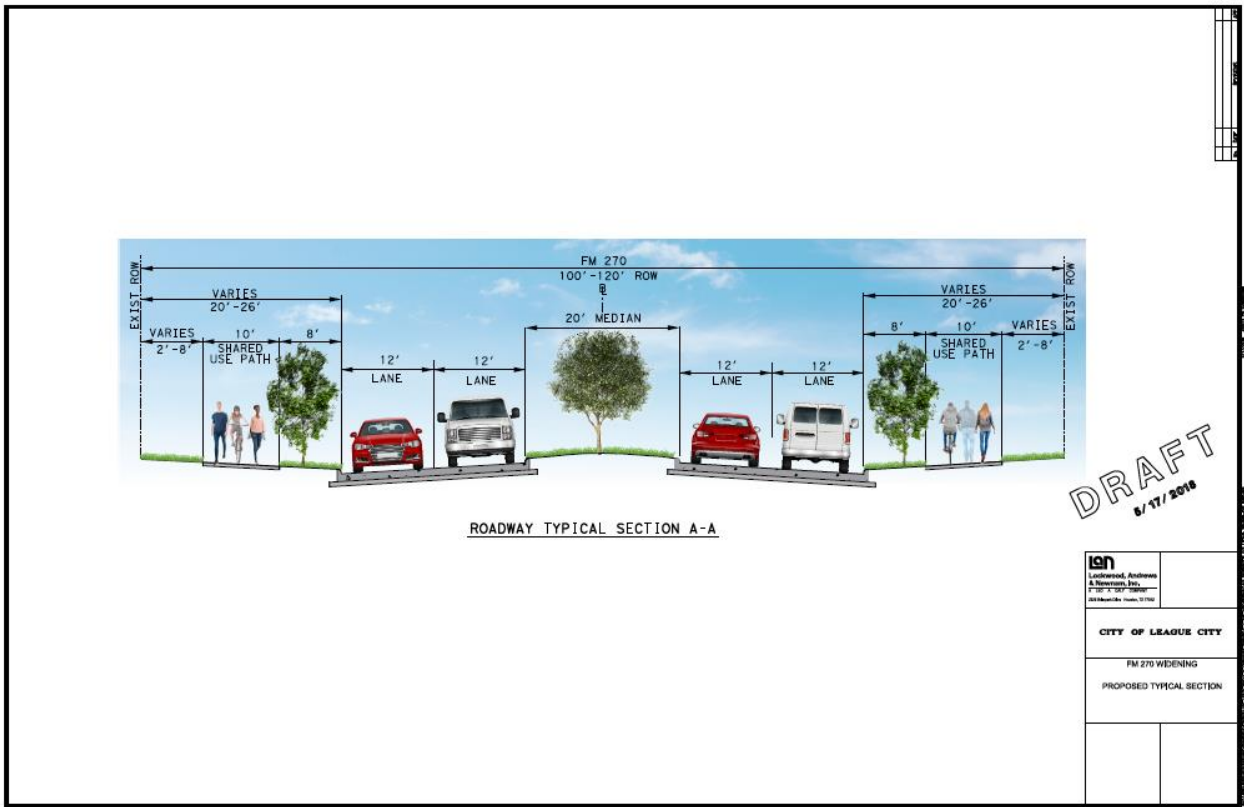
