PROJECT DESCRIPTION

The approximately 1.8 acre site serves as a neighborhood park with existing playground, trails, pavilion, baseball field and basketball court. Many of the existing facilities are aging and in need of replacement. The Parks Board desires to pursue a Texas Parks and Wildlife Department (TPWD) grant for this park. However, the project would not score well with only the park site and existing facilities included in the grant application. Therefore, the grant application will include utilization of city-owned non-park land such as detention pond(s) and levee and street rights of way as a match and to gain points for acquisition of land. The additional value of the land will allow for an increased construction budget for the project to enhance the facilities within the park and create a trail connection to the detention pond and development of minimal recreational features within the detention pond and along the trail to the pond as well as replacing existing park facilities and improving pedestrian connectivity through added sidewalks and trails. It is possible that some of the grant budget can correct drainage problems as well as providing recreational features.

PROJECT JUSTIFICATION

This project would be eligible for Texas Parks and Wildlife Department (TPWD) Grant Funds. Deadline for grant application submission is October 1, 2018. Matching funds for the project other than those from the value of land must be available at the time of the grant application.

PROJECT DESCRIPTION

The City has a partnership, through a Texas Parks & Wildlife Department Recreation Trail Grant opportunity, to construct a 5K Hike & Bike Trail on the grounds of Hometown Heroes Park. The 10' wide decomposed granite trail will run in its entirety, off road, and within the confines of Hometown Heroes Park. The total estimated cost of the project is \$1,493,300. This opportunity will use \$1,293,300 of City funds, and a \$200,000 grant from the Texas Parks & Wildlife Department. The City's contribution will come from 4B funds. The 4B Board approved funding support at the January 2015 meeting, with the understanding that approval of this project may delay a portion of the 2012 Hike & Bike Phase 1 Project (PK1202). The 4B Board felt this was an excellent opportunity to leverage its funds and reprioritize its projects since grant funds are available. This project is in the 2017 Parks Trails and Open Space Master Plan. The 5K Loop trail will be maintained by the City.

PROJECT JUSTIFICATION

Construction will provide a safer route for those who train for 5K running events. It will provide the only decomposed granite loop trail in the City. It will also allow the City an alternative route to host 5K runs instead of closing streets all around town. Races can be held at Hometown Heroes Park without having to close down numerous streets all around town for a race. This project is eligible for Texas Parks and Wildlife Department Grant Funding. Deadline is February 1, 2019. Funds for the City's match must be available at the time of the application.
