Interlocal Governmental Agreement for School Crossing Guard Program

This Interlocal Governmental Agreement for School Crossing Guards is entered into between the City of League City (the City), a political subdivision acting by and through its City Council, and the Clear Creek Independent School District, a political subdivision acting by and through its Board of Trustees. Both parties acknowledge that a School Crossing Guard Program is necessary to provide for the safety of students and citizens.

Term of Agreement

This Agreement begins August 1, 2018 and, unless extended by written agreement of both parties, ends July 31, 2021. Before the beginning of each school year, the need for crossing guards at particular locations throughout the City will be evaluated and revisions to the number and/or location may be made as the parties determine necessary. Any amendment shall be in writing and signed by both parties.

General Description of Services

Crossing guards will be employed by CCISD and assigned to campuses within the City of League City as determined by the parties. For the 2018 - 2021 school year, CCISD will employ and assign a total often (13) crossing guards, including a team leader, to campuses in the City of League City. The crossing guards will work in shifts ranging from two hours to four hours each day for 183 work days. A list of initial locations reflecting the number of crossing guards assigned to each location is attached as Exhibit A and incorporated by reference.

Consideration

The City agrees to pay CCISD a flat fee of \$82,975.86 per school year paid in two equal installments in January and July. This amount is subject to annual adjustment by the parties as necessitated by an increase or decrease in the number and locations of crossing guards. Any adjustment will be reflected in a written amendment to this Agreement executed by both parties. Exhibit A will be modified accordingly if and when adjustments are made.

Responsibilities

Each party assumes full responsibility for the actions of their own employees and each shall remain solely responsible for their own employees' subdivision, daily direction and control and payment of salary and benefits. At all times and for all purposes, the crossing guards employed and assigned under this program are considered employees of CCISD. The City shall have no duty of supervision or level of control over the details of their work and the crossing guards shall not be deemed to have any employment relationship with the City of League City.

Neither party waives or relinquishes any immunities or defenses on behalf of themselves, their trustees, officers, employees, and agents, as a result of the execution of this Agreement and performance of the functions or obligations described herein.

Miscellaneous

This Agreement shall be construed in accordance with the laws of the State of Texas. In no event shall any dispute arising hereunder be submitted to arbitration. Venue for any dispute arising out of the performance of the Agreement shall be in Galveston County, Texas.
