A canvass is the official tabulation of the election results. The City Secretary prepares tabulation from the original reports filed in her office stating for each the total number of votes received in each precinct and the sum of the precinct totals. This process is the same for the unofficial tabulation made on election night. The original of the returns is checked to make sure the original and the City Secretary's copy are in agreement and with verification that the information used in the tabulation is the same as the information on the originals, the City Council accepts the City Secretary's tabulation as the official canvass.
