A RESOLUTION WAIVING THE BOND ISSUE MINIMUM ON A ONE-TIME BASIS AND CONSENTING TO THE SALE AND ISSUANCE OF UNLIMITED TAX BONDS, SERIES 2019, UNLIMITED TAX PARK BONDS, SERIES 2019A, AND UNLIMITED TAX ROAD BONDS, SERIES 2019B FOR THE GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT #45 IN AMOUNTS NOT TO EXCEED \$6,450,000, \$2,940,000 AND \$1,775,000, RESPECTIVELY, AND AUTHORIZING THE MAYOR TO EXECUTE AND THE CITY SECRETARY TO ATTEST SAME FOR AND ON BEHALF OF THE CITY OF LEAGUE CITY

WHEREAS, the City Council of the City of League City, Texas, has reviewed and considered the issuance of \$6,450,000 Unlimited Tax Bonds, Series 2019, \$2,940,000 Unlimited Park Bonds, Series 2019a, \$1,775,000 Unlimited Tax Road Bonds, Series 2019b and the waiver of the requirement for a minimum bond issue by Galveston County Municipal Utility District No. 45.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

<u>Section 1</u>. The facts and opinions in the preamble of this Resolution are true and correct.

<u>Section 2</u>. The City hereby consents to the sale and issuance of \$6,450,000 Unlimited Tax Bonds, Series 2019, \$2,940,000 Unlimited Park Bonds, Series 2019a, \$1,775,000 Unlimited Tax Road Bonds, Series 2019b.

Se<u>ction 3.</u> The City hereby waives the requirement for a \$2,500,000 minimum bond issue by Galveston County Municipal Utility District No. 45 for the \$1,775,000 Unlimited Tax Road Bonds, Series 2019b.

<u>Section 4</u>. The Mayor is hereby authorized and directed to provide this evidence of same on behalf of the City of League City, Texas.

<u>Section 5</u>. All resolutions and agreements and parts of resolutions and agreements in conflict herewith are hereby repealed to the extent of the conflict only.

<u>Section 6.</u> It is hereby found and determined that the meeting at which this resolution was passed was open to the public and that advance public notice of the time, place and purpose of said meeting was given as required by law.
