A TRACT OR PARCEL CONTAINING 4.493 ACRES OR 195,710 SQUARE FEET OF LAND SITUATED IN THE EMILY M. AUSTIN SURVEY, ABSTRACT NO. 19, GALVESTON COUNTY, TEXAS, BEING OUT OF A CALLED 2.50 ACRE TRACT OF LAND, CONVEYED TO COASTAL COMMUNITY FEDERAL CREDIT UNION., AS RECORDED UNDER GALVESTON COUNTY CLERK'S FILE (G.C.C.F.) NO. 2003091547, AND ALL OF A CALLED 1.9081 ACRE TRACT OF LAND, CONVEYED TO JJJ WELL, LP, AS RECORDED UNDER G.C.C.F. LINE OF FM 517 (100 FEET WIDE), MARKING THE MOST SOUTHERLY SOUTHWEST CORNER OF UNRESTRICTED RESERVE "A" OF BAY COLONY APARTMENTS, MAP OR PLAT THEREOF RECORDED UNDER PLAT 18, MAP 1059 OF THE GALVESTON COUNTY MAP RECORDS (G.C.M.R.), FROM WHICH A FOUND CAPPED 5/8 INCH IRON ROD STAMPED "COBB-FENDLEY" BEARS FOR REFERENCE NORTH 30 DEG. 59 MIN. 15 SEC. WEST, A DISTANCE OF 0.60 FEET;

THENCE, ALONG THE CURVED NORTHWEST R.O.W. LINE OF SAID FM 517, WITH A CURVE TO THE RIGHT, HAVING A RADIUS OF 905.37 FEET, A CENTRAL ANGLE OF 10 DEG. 28 MIN. 28 SEC., AN ARC LENGTH OF 165.52 FEET AND A CHORD BEARING AND DISTANCE OF SOUTH 76 DEG. 32 MIN. 43 SEC. WEST – 165.28 FEET TO A CAPPED 5/8 INCH IRON ROD STAMPED "WINDROSE" SET MARKING A POINT OF TANGENCY;

**THENCE**, SOUTH 81 DEG. 46 MIN. 58 SEC. WEST, ALONG THE NORTH R.O.W. LINE OF SAID FM 517, A DISTANCE OF 298.34 FEET TO A CAPPED 1/2 INCH IRON ROD STAMPED "RPLS #1445" FOUND MARKING THE SOUTHWEST CORNER OF THE HEREIN DESCRIBED TRACT:

THENCE, NORTH 03 DEG. 04 MIN. 20 SEC. WEST, ALONG THE COMMON LINE OF A CALLED 13.428 ACRE TRACT OF LAND, CONVEYED TO MARIPOSA CALDER DRIVE LP, AS RECORDED UNDER G.C.C.F. NO. 2012031929 AND SAID CALLED 1.9081 ACRE TRACT, A DISTANCE OF 448.40 FEET (CALLED 444.37 FEET) TO A CAPPED 5/8 INCH IRON ROD STAMPED "COBB-FENDLEY" FOUND MARKING A SOUTHWEST CORNER OF SAID UNRESTRICTED RESERVE "A", AND THE NORTHWEST CORNER OF SAID CALLED 1.9081 ACRE TRACT;
