## PROJECT DESCRIPTION

With the popularity of the Lynn Gripon Park at Countryside Dog Park, completed in 2017, it became apparent that there is a need for another Dog Park further east or centralized within the City of League City. Therefore, City Council approved a \$200,000 budget for the Dog Park during the FY2019 CIP process. The design fee with TBG Partners is \$22,500, leaving \$177,500 for construction. Construction is anticipated May of 2020. Some of the additional cost for amenities may be borne by the League City Dog Park Association through fund-raising.

## **PROJECT JUSTIFICATION**

Due to the heavy use of the Lynn Gripon Park Dog Park, completed in 2017, located on the far west side of the city, it became apparent that there is a need for another Dog Park further east or centralized within the City of League City. This Dog Park, currently in design, will provide that needed facility.
