8. REPORTS FROM STAFF MEMBERS

John Baumgartner - a couple of quick announcements, I've been talking about the GO Bond program, projects are moving forward. We opened bids on the first project back in December, which was Calder Road and it's well under construction. The next two projects are two Bayridge drainage projects, the pump station and the internal improvements within the subdivision. Those will open bids in August, we hope they'll be under construction before the end of October. And we have a list of other projects that are moving forward related to drainage, including Oaks of Clear Creek, Countryside, Hidden Oaks, and Grissom Road. We talked a little bit about in the work session, the trail along FM270. That was bid by TxDOT. Those bids were opened slightly below budget and that should start in August. That's the final connection to get us open between 270 and Webster Street. We made some comments in the work session about that. Next month we're going to open the right turn lane at Hobbs Road on League City Parkway that will free up some bottleneck right there at Hobbs and League City Parkway. That bid opens in August. It's designed, so the bid, then after bid we have to schedule award and then start construction right after that, it'll go pretty quick. That'll move the signal pole that's in the way. Then League Park continues to make great progress. That park will be opened back up before Holiday in the Park in December. There's a bonus for September/October time frame completion, but we'll be well ahead of the winter holiday season. Then coming up in the next few weeks, there are some public meetings related to the drainage projects. We're holding those at the Civic Center to accommodate social distancing. Last night we held one on the Meadows and we also put it on Facebook Live. It's a way for the public to view it from home at the same time. Bayridge, we'll have a community update on where we are on their drainage projects on June 22. On June 30, we will have a Facebook Live townhall, update where we are. It's been just over a year since the bond program was approved, we'll kind of give a community update on where all those projects are, what we see as the next projects coming forth for design. Visit the City's website to keep up with that. COVID has cancelled many League City events so we try to get creative on what we do to continue moving forward. In the spring we contracted with AmeriWaste, our solid waste provider to do a household hazardous waste drop-off. In lieu of that we're doing curbside household hazardous waste. It requires more in some respects, for the public. You need to go to our website and every weekend is a different item. You have to call AmeriWaste to get on the schedule for what you have, then you leave it curbside and they'll come up and pick it up. From many aspects it will be more convenient. They'll collect appliances, electronics, tires and paint. That will be last. The drop-off is challenging because the lines get long, so the pickup, we'll try that and see how that works. We're excited that we can still offer that service and provide it safely. I'm excited to announce our annual fireworks extravaganza, we do that on the 3rd, so people can spend time with their families on July 4th. This year it's going to be a little bit different. We've still got COVID and social distancing, so we're calling it the drive-in fireworks show. We partnered with Clear Creek ISD in hosting the event at Challenger Columbia Stadium. Parking is limited, somewhere around 3,000 cars. We're going to open the gates at 7:00 p.m., fireworks will go off promptly at 9:00 p.m. and we'll continue to work on that event. No tents, no alcohol or private fireworks will be allowed.

Again, 7:00 p.m. the gates open, and at 9:00 p.m. the fireworks go off, and again, parking will be tight. Normally we have 10,000 to 20,000 people at our show, so it will be a little bit scaled back, but it is moving ahead. Finally, we have recognition of National Trails Week, our Parks and Recreation Department is currently hosting "Trailing in League City". League City has many miles of hike and bike trails and we want residents to get out and explore them by playing "Nature Bingo". Participants can download and print the bingo card from the City's website and bring their completed cards to Hometown Heroes Recreation Center. All participants will receive a tee shirt and prizes for the first 50 who come in with completed bingo cards. A short video of Lynn Gripon Countryside Park was shown.
