2. 20-0299 Consider and take action on a resolution authorizing an interlocal agreement with Galveston County to allocate eighteen percent (18%) of the City's CARES Act Coronavirus Relief Funds to Galveston County for continued nasal swab and antibody testing for residents (Mayor Hallisey)

A motion was made by Mr. Mann, seconded by Mr. Dugie, to approve Resolution No. 2020-90 authorizing an interlocal agreement with Galveston County to allocate eighteen percent (18%) of the City's CARES Act Coronavirus Relief Funds to Galveston County for continued nasal swab and antibody testing for residents.

A motion to amend was made by Mr. Long, seconded by Mr. Mann, to approve under the terms discussed in this meeting and to clarify those terms: for the City of League City to be invoiced monthly for corona virus testing conducted on League City citizens (Galveston County and Harris County), capped at 18% of League City's CARES Act relief funds.
