

ORDINANCE NO. 2020-

AN ORDINANCE DECLARING ELECTED THE UNOPPOSED CANDIDATE FOR CITY COUNCIL POSITION THREE FOR THE CITY OF LEAGUE CITY, TEXAS; PROVIDING THAT THE NOVEMBER 3, 2020 ELECTION SHALL BE HELD FOR CONTESTED COUNCIL POSITIONS 4 AND 5; CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH.

WHEREAS, pursuant to Ordinance 2020-19, passed and approved on August 11, 2020, a general municipal officers' election was ordered to be held on November 3, 2020, for the purpose of electing three (3) officials of the City, to-wit: Council Positions 3, 4 and 5; and

WHEREAS, pursuant to said ordinance and Sections 143.007 and 146.054 of the Texas Election Code, the deadline for filing applications for a place on the ballot and declaration of write-in candidacy for the City's municipal officers' election has expired; and

WHEREAS, the City Secretary, in accordance with Section 2.052 of the Texas Election Code has certified to the City Council in writing that Larry Millican is unopposed for election to the office of City Councilmember Position 3; a copy of such Certification of Unopposed Candidate is attached hereto as Exhibit "A" and made a part hereof; now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

Section 1. The facts and opinions in the preamble of this ordinance are true and correct.

Section 2. In accordance with Section 2.053(a) of the Texas Election Code, the following unopposed candidate is hereby declared duly elected to the respective office shown and shall be issued a certificate of election following the date the election was to have been held in accordance with the Texas Election Code:

Larry Millican – City Councilmember Position 3

Section 3. Pursuant to Section 2.053(b) of the Texas Election Code, the general municipal officers' election heretofore called and ordered pursuant to Ordinance 2020-19 shall not be held for the office of City Councilmember Position 3. The election heretofore called and ordered pursuant to Ordinance 2020-19 shall be held for contested Council Positions 4 and 5.

Section 4. All ordinances and resolutions, and parts of ordinances and resolutions in conflict herewith, are hereby repealed to the extent of the conflict only.
