RESOLUTION NO. 2020-

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, POSTPONING THE ISSUANCE OF CERTIFICATES OF OBLIGATION; AND MAKING OTHER DETERMINATIONS INCIDENTAL THERETO

WHEREAS, on August 11, 2020, the City Council (the "City Council") of the City of League City, Texas (the "City") approved the publication of a notice of the City's intention to issue its Combination Tax and Revenue Certificates of Obligation, Series 2020 (the "Certificates") in an amount not to exceed \$11,500,000 for the purposes of evidencing the indebtedness of the City for all or any part of the costs associated with providing all or part of the funds to pay contractual obligations to be incurred for the construction of any public work, purchase of materials, supplies, equipment, machinery, buildings, land, and rights-of-way for authorized needs and purposes, to wit: (i) acquisition, construction, extension and improvement of the waterworks and sewer system and (ii) payment of costs of professional services related thereto; and

WHEREAS, the City Council was scheduled to authorize a parameter ordinance for the Certificates on October 13, 2020; and

WHEREAS, the City Council finds that it is in the best interest of the City to postpone and delay the issuance of the Certificates until such time as it deems necessary; and

WHEREAS, the City Council desires to postpone the preparation of a preliminary official statement due to the delay of the issuance of the Certificates; and

WHEREAS, at such time that the issuance of the Certificates is deemed necessary by the City, the City Council will authorize a resolution approving a notice of the City's intention to issue the Certificates and such notice will be published in accordance with Texas law; and

WHEREAS, after the publication of the notice of the City's intention to issue the Certificates in accordance with Texas law, the City Council will adopt a parameter ordinance authorizing the sale of the Certificates and other matters incidental thereto; NOW, THEREFORE

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS THAT:

- <u>Section 1.</u> The findings, determinations, definitions and recitations set out in the preamble to this resolution are found to be true and correct and are hereby adopted by City Council and made a part hereof for all purposes.
- <u>Section 2.</u> The City Council hereby authorizes the postponement of the issuance of the Certificates consistent with the findings and determinations of this resolution. This resolution shall take effect immediately upon its passage.
