PROJECT DESCRIPTION

Annual Program to resurface/rehabilitate over asphalt street on a 10 to 12 year cycle. An initial list includes but is not limited to: Shellside, Historic District North and South of FM518, W Wilkins/ W Saunders, W of RR Tracks, Historic District

FY2019: \$2M to be invested on the following streets - Package 4: W. Wilkins, W. Saunders, Interurban, David Ave, Historic District Streets (N. Michigan, Colorado), E. Wilkins, E. Saunders, Houston Ave (FM518 to E. Galveston), E. Galveston, Illinois (Walker to Beaumont), S. Kansas (Walker to Beaumont)

FY2020: Investment on the following streets as funding permits: Package 5 (RE1704E): N. Wisconsin, Cove Park, Mission, Monterey, Redwood, Rimrock, Sequoia, Shasta, Sierra, Winn, Knollwood, Power St, Coryell asphalt rehab from Railroad Ave to N Kansas, Delaware, Tallow Forrest, and Mary Lane (\$100,000) for hot mix asphalt contract for city-wide street repairs; Elmore St, Calder Rd, Grissom Rd, and Glen Cove Blvd.

FY2021: Design Package #6 -N.Illinois, 2nd and 3rd streets between Wisconsin and Alabama, Seminole, Glen Cove Blvd, Tallow Forest, Mary Lane Construct Package 5; (\$100,000) for hot mix asphalt for city-wide street repairs, Arizona, League St Strawberry, Hawaii, Idaho, West Independence.

FY2022: Construct Package 6, Design Package 7- Lake Side Dr from West Dr to Mockingbird, West Dr, Valmar, Oak Rd, Mockingbird, Bluebonnet

FY2023: 7th, Landrum, Moody, Cedar & Linda streets; Boden & Bern (coordinate with waterline replacement)

FY2024: Austin (FM270 to Texas - widen also); Power St

FY2025: West NASA Extension (asphalt loop from FM528 to West Nasa concrete)

PROJECT JUSTIFICATION

With maintenance our asphalt streets should last 40 to 50 years. This maintenance should include a regular resurfacing program.
