

ORDINANCE NO. 2021-09

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS TO CREATE THE KEEP LEAGUE CITY BEAUTIFUL COMMITTEE AND DISSOLVE THE LEAGUE CITY CLEAN AND GREEN COMMITTEE

WHEREAS, on March 14, 2017, the City Council approved Resolution 2017-46 which created the League City Clean and Green (“Committee”) to protect and preserve the environment; and

WHEREAS, there is a need for citizen input related to upcoming art and beautification projects within the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEAGUE CITY, TEXAS, as follows:

Section 1. The Keep League City Beautiful Committee is here by created, with its purpose to provide recommendations on City projects and initiatives related to:

- public art
- placemaking opportunities within League City
- availability of art and cultural services, programs, and community events
- beautification, anti-litter, and recycling efforts

Section 2. The Keep League City Beautiful Committee is an advisory board and will be composed of eight (8) members each serving a two (2) year term.

Section 3. Each member of the Keep League City Beautiful Committee must be: 1) a registered voter of League City; 2) own a business in League City; or 3) work in League City.

Section 4. The City hereby appoints the people listed in **Exhibit A** as the initial board members to the Keep League City Beautiful Committee according to the schedule set forth therein to allow for the terms to be staggered.

Section 5. The League City Clean and Green Committee is hereby dissolved.

Section 6. Savings. All rights and remedies which have accrued in favor of the City under this Ordinance and amendments thereto shall be and are preserved for the benefit of the City.

Section 7. Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid, unconstitutional or otherwise unenforceable by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 8. Repealer. All ordinances and parts of ordinances in conflict herewith are hereby repealed but only to the extent of such conflict.

Section 9. Publication and Effective Date. The City Secretary shall cause this Ordinance, or its caption, to be published in the official newspaper of the City of League City, upon passage of such Ordinance. This Ordinance shall become effective on passage.




