Ms. Sanborn said I would like to thank everyone who came and spoke to us tonight. I just want to say you are not going to be treated like red-headed stepchildren. You are going to be treated with respect and your opinions are going to be heard. From the Library, the weekly "Friday Frolic" program is at 10:15 a.m. and is designed for pre-school children. The featured program this week is "Jazzmatazz" which combines aerobics and jazz dance for young children. It is open to all preschoolers and their parents. On Monday, October 4th, at 1:00 p.m. the topic for the Library's monthly "Art and Antiques Roundtable" is quilts and quilting. Everyone is invited to bring their quilts to share and discuss. On a personal note, I want to remind everyone, regardless of where you live, when you park your car make sure your doors are locked and make sure every window and every door in your house is locked. This gives me an opportunity to brag on our Police Department. Last Tuesday my home was burglarized. A neighbor saw someone jump over the fence and called the Police. They were able to apprehend the alleged criminal with some of my stuff. He had been in a couple of other houses and had attempted to get into others. Your home is your sanctuary and when someone invades it, every little bit of peace of mind is taken away. I have three watch dogs. They watched them come in, they watched them take things, and they watched them leave. Nothing is safe. Be careful. National Night is coming up on October 5, 2010. Make an opportunity to meet and get to know your neighbors. Let's look out for one another.

Mr. Baron said I want to follow up Ms. Sanborn's comments. We do have a "Lock, Take, and Hide" program in the City. Our Police Department has been involved with it. Some people are skeptical but the reality is the Number 1 deterrent to crime is your neighbors' eyes on the street. It is good timing as we sit here preparing for National Night Out next week. One of the concepts behind National Night Out is to create familiarity among neighbors. Other concepts are keep your eyes open, use common sense, lock your stuff up, take your keys with you, and hide anything valuable. The second thing I would like to comment briefly on is board appointments. We had a number of citizens speaking tonight about issues that are important to them and their neighborhoods. For people who want to be involved in City operations on a regular basis, we have board applications on our website. We have a number of boards and commissions that are involved in critical decisions that are made here at this table. You can help us by filling out those applications, serving on those boards and commissions, and giving us a broader spectrum of opinions. We all live in this fast growing City.

Mr. Barber said I was not really prepared to say anything. However, I endorse the whole idea of people going to National Night Out events in their neighborhoods. It is very important. Not only do you get to meet and greet your neighbors but you really get to be a part of the community partnership with the Police Department. Many neighborhoods participate. Some do not. You can probably find information through the League City website, www.leaguecity.com. If not, send me an email and I will find the information for you.
