Joanna Dawson said Happy New Year everybody. I don't have any big comments tonight. Keep doing the good stuff you're doing and let us know what kind of things that we need to be working on. Some of the issues that you've recently brought to our attention, we are on top of and have solved a whole bunch of them. That's real important.

Heidi Thiess said hello everyone. I want to give hearty congratulations to our Parks Planning Department. I was at H-GAC last week and I want to point out that the Clear Creek Paddle Trail was selected as the winner of the 2013 Houston-Galveston Area Council Parks and Natural Areas Award, in on the ground projects under \$500,000 category. The project serves as a model for other projects in H-GAC's thirteen-county region. H-GAC is the region wide voluntary association of local governments in the Gulf Coast Region of Texas and so on and so forth. Winning entries demonstrate best practices and collaboration between developers, local government, engineering and planning agencies, businesses, resources, environmental groups, and citizens. Did you know that we got that award? The entry was evaluated on innovation, merit, and regional impact and the project serves as a model for planning and project implementation for parks and natural areas in the region. John Orsag was there. He is the Parks Coordinator for Parks Planning for League City and I just want to send congratulations out to the Parks staff. I also want to point out that on February 18 early voting starts for the primaries and just make sure that you're aware that it's everyone's duty and privilege to vote.
