8. <u>COUNCIL MEMBERS COMMENTS/REPORTS</u>

Announcements concerning items of community interest. No action will be taken or discussed.

Dennis OKeeffe said one quick reminding everyone that this is Mr. David Benson's last council meeting and I just wanted to thank you, Mr. Benson, if he's in the room, for time served. You were always my go-to point guard when there were questions that needed assistance on generating agenda items and I've always received those responses in a timely manner. I realize your job was not completely understood by everybody, but it was well understood by myself and I'm going to miss your service at the City and wish you the best of luck in your future endeavors.

Joanna Dawson said I would like for John Baumgartner to stand up, please. John, I just want to thank you for the great job you did in your interim role. You were always Johnny on the spot and used good judgment as far as we could tell and you were very responsive. Very good job. Thank you from all of us.

I have one more thing. We all get so bogged down in infrastructure and construction and zoning and all that kind of stuff in our town, but we are still a town and I have a town item that I would like to pass on to you all. Right now it's on Channel 13 at 6:00 p.m., but we have some historians in town who have been working on a couple of World War I soldiers who finally their bodies were delivered to League City in 1965 and they were buried at Fairview Cemetery without the normal veteran's headstone. The reason was that they didn't have any next-of-kin, so Debra Gammon, who is a historian in League City, has been working on this for three years to establish what was necessary to have the Veteran's Administration give them a headstone. Finally it has been approved and we're going to have an official headstone placement sometime soon. So think about all this modern stuff, but there are still some guys who are looking for their reward. I thought you all should know that.

Heidi Thiess said welcome everyone. If you remember back in January we had discussion and kind of a crash course in the electrical grid in capacity market proposal for the State of Texas. In that timeframe having presented a lot of information to the council, we decided to go ahead and approve a resolution opposing a regulatory change, a re-regulation of the electrical market to a capacity market which would add anywhere from three to five billion dollars in surcharges that would then be passed through to the energy producers for no additional use of our own which would add about thirty to thirty-five percent to every single person's electrical bill. Industry was against it, cities were against it, towns were against it, but League City actually did something about it and we passed the resolution in January because at the time they were in a decision making mode. They were waiting for a report to come out from ERCOT that would describe what our reserves were going to be in the upcoming years and then they were going to make a decision. I need to remind you that's a three person panel, three commissioners, that are unelected, they are all political appointees, were going to make a decision, take it back out of the legislature which deregulated the market in 2001 and reregulate it, thereby adding an instant thirty percent surcharge for no additional usage. So the resolution that we passed went to the PUC and it also went to our representatives and it created, not necessarily that ours created a stir, but the fact that municipalities and towns were paying attention to what the PUC was trying to do in an interim session behind closed doors.

Well the report came out from ERCOT and it was way better than anybody expected. Our electrical reserves for years to come are far more than what they had initially projected. It's a very highly successful report that came out so the PUC said "Okay, okay". They cooled off a little bit. They cooled their jets and they thought well, we will wait until May to make a decision and then finally they said you know what, this is a legislative decision, it needs to be made by the representatives of the people which is all we were asking for in the first place. I wanted to pass that along to you because that was kind of a crash course in the electricity market back in January. Score one for the people. That's a great decision and I just wanted to pass along that success to you and to also thank all the council members, everybody that took action on that. I think that was a great example of communities stepping up at the PUC and they noticed, so that's good. I have one more announcement. This is a community announcement. A few months ago we had young lady in here, she's a cancer survivor and she did "Friends Through The Fight". If you remember we had that for a community spotlight. She asked me to pass along to my fellow council members, which Diana did today, an invitation to a golf tournament. I also wanted to mention it to you because they are looking for everything from donations to golfers, golf teams, sponsors, and everything. This is the lady out in Magnolia Creek, Jackie Svoboda. This was going to help raise funds. They were able to disperse about \$10,000 in support of women that were under treatment for cancer and they would like to keep the tradition going this year. Andy Mann said there is so much to talk about I could go on for thirty minutes today. Instead I think I'll just talk about the original dream that I had when I ran for office. I think League City can be the best city in the Houston/Metro area. I honestly believe that. And all it really takes, through all my years of being in and out of the system and working around it, all it takes is a clear vision and guts. The last three and a half years I've noticed that I've been able to eke out small successes, but those were incredibly difficult. It's amazing how hard it is to get something good done through the system. The system's set up that way, but I'm very hopeful. There are moments whenever, I guess I've interviewed with lots of people, and there are moments when you know, that's the guy. Mark pulled out a piece of paper with a visioning document. It was a very basic step by step plan on how to create a vision and I was like, yeah, this is it. There were a lot of great candidates, I won't kid you. I just hope that over the next six months that we don't wait, that we start this process and in two or three years from now when I'm skating in the skate park and hanging out looking back at you guys, I hope that this was the moment that we pulled it together.

Geri Bentley said I would like to say farewell to Mr. Benson, thank you to Mr. Baumgartner and welcome to Mr. Rohr.

Dan Becker had no comments.

Todd Kinsey said I, too, will miss Dave. We're always trading little barbs and texts and stuff. I'll miss Dave. Again, John did yeoman's work in the driver's seat, in the interim. This Saturday is the Salute To Heroes Benefit. There are still a few tables remaining, but we are over the top. The home will be built. A young marine, whom I still can't release the name, has been selected because it's still a secret. He doesn't know. He will be moving here from California. He lost both his legs to an IED. He will be coming to the League City community soon. We had all kinds of things donated behind the scenes including a lot. I believe I've got a commitment for a truck from one of our local car dealers who is wishing to remain nameless because they don't want to be drug through the mud. On Thursday, April 10 from 4:30 p.m. to 5:15 p.m. elementary school children will have the opportunity to create their own Faberge egg.
