Todd Kinsey said there is always great stuff happening at the Library. Tomorrow is the last day to turn in Summer Reading Logs at the Helen Hall Library. They will be accepted up until 9:00 p.m. when the Library closes. The Library's Super Reader Party is on Thursday, July 30, at 6:00 p.m. to 7:45 p.m. This is for children completing one or more reading logs and will be held in the Civic Center, not the library. Finally the Antiques Round Table will meet in the theater at 1:00 p.m. on Monday, August 3. This month's topic is Love of Antiques. Participants may bring any antique item they would love to share with the group.

Dan Becker had no comments.

Nick Long said what I want to speak on real quick, this is my first budget and I've been going through it and digesting the different parts of it. One part I really found interesting is when we got into this, I have a lot of experience dealing with different municipalities across the state of Texas, so when we started looking at it, how the City of League City really ranks with cities our same size. So we went and took cities from 75,000 people to 200,000 people and compared the number of employees per thousand citizens and when you break that down the City of League City is at 5.93 employees per citizen and in our kind of peer group that is the second lowest behind McKinney of any of the peer group. Brownsville has a Public Utility Board which is a separate entity that's run completely and I'm actually going to bring up the Brownsville Public Utility Board later on tonight. So out of the cities that do everything that we do, we have the second lowest number of employees per citizen and I think that speaks to the overall level of efficiency in the City of League City and I congratulate our staff and management for keeping it that way but that also goes to show that now we have been entrusted to make sure we continue to run that efficiently. So as we are going through this budget process and tonight we're going to take another step by drastically reducing the tax rate, taking more money out of the budget again, reducing the per capita spending and I would like to encourage everybody, and I know they will, to continue to be budget hawks, look there to see how we can further reduce the spending while making sure that we keep the services and the response times and the overall quality of living and the reason that people live in League City in the first place, because it's a great area to live.

Keith Gross said good evening everybody. Thank you for coming to this League City council meeting. Over the last few months, council has touched on many sensitive topics including Mar Bella and one of the things that I've always encouraged is people of League City to participate in government. One way is voting and another way is coming here and making your voices heard. I would like to encourage those people that have opinions on various resolutions or ordinances that we're considering to email me. I would be happy to know what your thoughts are on the matter and the reasoning behind them because that's one way to be heard. If I'm getting 15 or 20 or 100 emails on a particular topic, I'm really going to take that to heart when making my vote up here so I do want to encourage the people of League City to get involved in government and send your councilman an email and let them know how you feel. There are a few select people that do that, but not enough. More people need to be involved in government.

Heidi Hansing said I've got some great news because I had a chance to attend the HOA that all comes together once in a while and I want to thank Laura Teatsworth for the invitation and I'm going to share with you the information I shared with them. I don't know if you know but League City has made the list of best places to live in Texas and I wanted to find out how we ranked. It kind of goes back to what Nick was saying as how do we stack up against other communities our size and with our amenities. The interesting thing that popped out to me is that we are in the fastest growing state in the country. According to a report from the most recent US Census Bureau, 7 of the 15

fastest growing cities with populations of 50,000 or more are located in Texas. The state saw an overall population growth rate of 5.4 percent from 2010 to 2013 and has seen growth spikes as high as 9.2 percent. I want you to keep that number in mind, 5.4 percent, because when you scroll down and you look through the places of the best places to live, League City is right there at number 8. It says League City is notable, not just for it's' quality of life but also for its growth. Bear this in mind, the population increased 8.9 percent from 2010 to 2013, which is 3.5 percent more than the state's average. League City is growing faster than the fastest state in the union so this requires some management and this requires some creative ideas and this requires your input. We didn't know this when we organized, many thanks to our staff and Mark Rohr, the Envisioning Process that we had back in February where we had a great turnout of people who came to tell us how they would like to see the future of League City, what would we like to see for the community that we live in. What is it that makes League City so great? Well the people spoke and I want to remind everyone who was there because many people who are in the room weren't and other people who are watching at home were in the room, great turnout but we were not allowed to speak. Council sat there while we heard from the citizens of League City what they wanted. So I want to remind everyone of some of the things that are now coming to fruition today that came out of that envisioning process. The people of League City spoke. They said we want this, this and this and I'll show and remind you of what you all said you wanted. Then you also gave us some mandates on moving forward and some ideas on how you wanted to see it enacted. Not us, we're not the be-all end all. We're not the be-all deciders for you guys. We shouldn't be. So anything that comes out of this we have to put in front of you for your approval going forward. If we were to withhold that information and say you guys don't deserve to know, we'll decide, we'll take it from here. What kind of hubris would that take for us to say we got this you don't get a say. So let me go back and remind you. While you guys were talking, staff was taking notes and it was all live entry. There was no debate. Council didn't get to schmooze you all. We didn't get to massage the information. This is exactly how it came out of the people that night. You told us you wanted debt management. You told us that was an important issue to you and when you said that it became a paramount issue to us. You said you wanted codes and ordinances updated, you said you wanted enhanced communication to residents. You wanted an animal shelter, community facilities master plan. Council came through and said good, we're going to work on this. The important thing I want to point out here is we haven't had a plan for a very long time. That was one of the frustrations that we had first coming on council, how do we move forward if we're just going to be willy-nilly, if we're not going to have a plan. This right here gave us a plan and right here at the very top you're going to see economic development and all the way down through it, look at where all those dots are, on the development of a central historic and business district. All of these ideas...waterfront development, make it an easier place to do business, planned growth, attract corporate headquarters, streetscaping, enforcing historic standards, quarter cent sales tax dedicated to an economic development fund. That wasn't us. That wasn't our idea. It's been tried before but we live in a very highly educated, white collar, exploding-growth city. You guys get it and you guys are giving us direction. If we don't follow what you tell us to

say and do, what are we for, unless you wanted us to be deciders? That's not what I thought you elected us for. We have a list here going forward that was then translated into a Roadmap to the Future. Very succinct, not too long, not full of a lot of politico-speak and legal ease and we passed a resolution unanimously, the council did, in February of this year. The resolution stated that whereas citizens from the community, the city council and city staff met as a group, whereas citizens from the community met and created a list of important projects. Whereas the city council as the policy determining body affixed dots to the ideas advanced to signify their votes and priorities for projects and whereas city staff compiled votes and summarized them on the City of League City's Roadmap to the Future. Whereas the City Council deems it in the best interest of the citizens to adopt the City of League City's Roadmap to the Future as it closely aligns with the guiding principles, goals, and policies of the Comprehensive Plan of the City. We resolved by the City Council unanimously to follow the Roadmap that you gave us. To that end we have been moving within the first 1 to 3 years you gave a list of projects to accomplish and shame on us if we don't because we're not following your directions. Economic development, with eight Council Members saying Economic Development is right at the top developing Industrial commercial mix, partnerships, develop League City as a destination, waterfront development implement quarter cent sales tax dedicated to economic development and planned growth. Those were your directions to us, those were your marching orders, and we're doing everything we can to follow what you're telling us to do. However, you guys have the final say. We can't make that decision for you, so tonight on our agenda we're going to have a vote on whether we put this on the ballot so you guys can give the final say or not. If we decide you don't get the final say, and Council wants to reserve that to itself, how would you guys feel about that? Or, we could say well you guys gave us marching orders, if we don't do this our Roadmap to the Future, our ten-year plan is obsolete before it even hit the road.

Geri Bentley said to continue on what Heidi was saying, every week that we have a council meeting, this Road Map to the Future is at the front of our agenda so we don't forget what you all want us to do. We get a weekly reminder every week of what this is so that we know how to do this. We are following it the best we can. Several weeks ago I had an opportunity that TML (Texas Municipal League) offered, a Legislative Update and I was fortunate enough to go to Austin for a day and listen to all the different laws and things that were passed. TML represents the cities and all the counties in the state and so all the things they were talking about were things that affected either a city or county. We had a large update so I brought it back and passed it out to all my council members so they could see what I was learning. Heidi also attended this. I also passed it out to our staff so that they could see these bills also which affect the citizens in the city of League City and the county.

Tommy Cones said thank everyone for coming out tonight. We also have another special little guest in our audience, if I can just recognize her. Ms. Texas Little, would you stand up and just wave at everybody.
