**8. COMMENTS/REPORTS FROM MEMBERS OF COUNCIL**

Announcements concerning items of community interest. No action will be taken or discussed.

Nick Long said thanks for everybody coming out tonight. Pretty good crowd and we're looking forward to addressing the United Methodist land later tonight and I know that's a big concern to most of you. I'd also like to talk about an upcoming event that's going to be at the Sportsplex or at the Hometown Heroes. It's going to be on Friday, September 16, and it's going to be a mother's day out or parents' night out. You can drop your kids off, they have games, they have sports, they have different things going on. You will be able to go on a little date night, come back pick up the kids. It's a low cost babysitting option provided by the City of League City.

Dan Becker said there seems to be some misunderstandings about some of our boards and how they function. Mr. Doan is probably much better qualified to speak about this matter, but this is not his opportunity to address council in this meeting. The Ethics Board is a quasi-judicial board. They act on matters somewhat akin to a judge and a jury. So for that board to consider anything but the facts as presented to them by the attorneys would fly in the face of the way our judicial system works. Many of you have been on juries and it is very typical for a judge to direct the jury to not even have discussions amongst themselves until the charge has been given to the jury by the judge. They're reminded not to listen to the news media, not to watch television, not to discuss things with their family or the media. So for us to have an ability for the public to address the jury essentially in the Ethics Board would fly in the face of proper judicial procedure.

Heidi Hansing had no comments.

Todd Kinsey said I will be quick. I also live in MUD 7, the Lakes of South Shore Harbour and around 2:00 p.m. this afternoon my phone and Facebook just started absolutely blowing up, so I think it's prudent that we put this off and at least get the residents some information. Even I, being on council had to scramble to get information. Beyond that, I just wanted to again thank BAHEP. I've done two of their NASA trips and actually got to lobby for the Houston area, League City area, on one of those trips with Bob Mitchell, the president of BAHEP. The Salute to Heroes benefit that we put on once a year, partnered with their Veteran's Mentoring program and all the proceeds went to that program which I feel great passion about, giving back to the veteran community. Finally over at the library, Amelia Chow will teach a class on Basic Mouse Skills at 10:00 a.m. on Wednesday, September 14 in the second floor lab. On Thursday from 4:15 p.m. to 5:00 p.m. in the library theater, the Webkinz Club meets to celebrate Back To School. That's for children ages 4 to 11 and they are invited to bring their favorite Webkinz or stuffed animal for fun and crafts. Finally, Saturday, September 10 at 10:15 a.m. in the Board Room, the Teen Writing Club kicks off and that's for ages 6th grade through 12th. Thank you and everybody have a blessed week.

Keith Gross said good evening and welcome. Up here we usually and almost always talk about issues facing League City as a whole, but I want to use a minute or two to deviate from that. I hope I keep my composure. A couple of weeks ago Ms. Harmon told me about a Joseph Fleming, a boy in 5th grade, who has an unforgiving form of cancer and we talked about this charity event going on October 1 and 2, but most of all I think this boy needs your prayers. Please say a prayer for him tonight. Thanks.

Mayor Hallisey said I do want to thank the League City Volunteer Fire Department. That was an impressive thing that happened there on Sunday morning when they climbed the stairs up at the drill tower, I think 28 times, each one, a lot of them in full gear. There were fire departments from all over the region who came. There were 346, I believe, firemen in New York City that lost their lives on 9/11 and they commemorated that. It was quite an event. There were a couple a hundred citizens out there and family members, so everybody, keep them in your prayers as well. I had a chance on Saturday to go to an Eagle Scout Court of Honor for Joey Cesarini. I'm never going to get that name right. A 17 year old that goes to Clear Springs High School. A fine young man who got 54 merit badges which is the absolute maximum that you can get. He's a robotics team member. I had the opportunity to meet such great young people, and I was privileged to be there with him. I also attended Dominion Church for two services on Sunday. I had an opportunity to speak on 9/11 and talk about the very moments that most of us will never forget where we were at the moment the news came across and what was going on in this country and we learned rather quickly that wars that were being fought overseas could get to us and it was a horrific thing. I want to thank Pastor Greg Thurstonson who invited me. He came to speak two weeks ago, to give our blessing and now we're praying for him because he's in the hospital with pneumonia and was not able to be there but his assistant pastor was magnificent. I attended the League City Chamber of Commerce Patriot's Luncheon on last Friday, where our police department, fire department, our EMS services, and the sheriff's department were all honored. Our first responders. I was really proud to be part of that. Each one of those groups acknowledged somebody within their department who had done an absolutely exceptional job and I was reminded, these people walk up on cars and they have no idea what's going to happen the next moment or they walk through a house they have no idea what's on the other side of the door. There are firefighters who put their lives at risk and in our city, volunteers, who stand up for us to protect our assets and to protect our lives. Emergency medical people who get us to the hospitals if we're hurt and as I was reminded the other day, the energy company Texas New Mexico Power was there and those are all first responders and those are the patriots and the champions of our community. If you would just join me in applauding those people and the great job that they do. I want to say one thing. I think Janice talked to Kim today and she wanted to make sure I gave Joseph Fleming a shout out but I want to give him a little more than a shout out and I want to amplify what Mr. Gross said. He's in our prayers every day. Who has a camera? If we can get everybody to stand up and give Joseph a shout out and you can take a video of that, we'll send it to him. We hope that lifts his spirits and that we pray for him every day.
