8. <u>COMMENTS/REPORTS FROM MEMBERS OF COUNCIL</u>

Announcements concerning items of community interest. No action will be taken or discussed.

Dan Becker had no comments.

Hank Dugie said I was at the Evening in the Park last week and it was a huge success. The whole park was full of League City citizens, most of them with their pets but some of them without, just there for their community. While I was there I was able to talk with dozens of citizens that don't usually show up to these meetings. Sometimes here in our little bubble, we think these are all the people that exist but really there are a hundred thousand people out there in League City who have their own wants and needs and desires and it's as much our job to represent them as it is to represent the people in this room. While I was at the event I realized what that space could be used for. If we had dedicated planning, people organizing events there every weekend, once a month at least, we really could have a great turn out for those and more so than just getting numbers to show up, we could be impacting lives. I think that citizens in League City, they want to play in League City, they want to enjoy their families in League City, and that one of the gems of League City is the park. We need to be deliberate with how we go about developing the downtown but I'm heartened to know that there are people out there that are going to use the space. I just want to make sure we keep the charm that currently exists but expand it and make it more amenable to everybody. Thank you to Sandra for putting that event on and to her team. I look forward to many more events out there.

Heidi Hansing said I want to talk a little bit about a topic that we're going to be addressing in council in a couple of weeks. After the 84th legislative session, the Lieutenant Governor Dan Patrick issued an interim charge to the entire Texas Senate and that was to evaluate the security of the Texas Electric Grid. We are in a unique position here in Texas where more than 85 percent of our entire electric grid is proprietary to Texas and the study came out of many decades of research commissioned by Congress by the Federal Government to study the impacts of terrorism, cyber-attacks, and EMP threats to our electrical grid.

If you'll recall back in the spring, in April, Mrs. Bentley and I attended the Texas Grid Security Summit in Austin. That was hosted and that came out of the interim charge from the Lieutenant Governor and was hosted and put together by Texas Senator Bob Hall. From that we promised to bring you back information and to address it with you as citizens and to address it also as a city, so in two weeks we will be presenting a resolution of support for the Texas Senate and I should add too that there was legislation on the books and in the 84th legislative session, it was successful in the Senate, but it died in Calendars Committee in the House where a lot of good bills go to die. They just end up not pushing them out to the floor for a vote, but the Governor is in favor of it, the Lieutenant Governor is in favor of it, as well as the Texas Senate so they have asked for our help and that is to engage municipalities and counties at a local level in order to push out this information, to let people know, to educate people as to the efficacy of protecting our proprietary grid in Texas. I just want to read you something from Senator Bob Hall. "For those of you who are unaware, an EMP or electromagnetic pulse is an instantaneous burst of electromagnetic energy capable of destroying solid state electronic systems and electric power networks. This destructive effort can occur from a natural event such as an intense solar storm or a man-made deployment of a low yield nuclear weapon detonated at high altitude or from a more localized intentional electromagnetic interference device. Experts have warned for more than two decades of the electric grid vulnerabilities to physical, cyber, and EMP threats, however unlike physical and cyber, the nation's electric grid has not been adequately protected against EMP threats. More than eleven comprehensive studies either authored by or for the government have detailed the seriousness of the threat to electronic based infrastructure and specifically to the nation's entire grid. The most recent came from the GAO audit that demanded federal agencies work rapidly to close the space, weather, and electromagnetic vulnerability gaps to the U.S. power grid. That's been going on for 20 years. For more than 50 years the U.S. military has known about the seriousness of the threat and in fact, the DOD strictly adheres to several protection standards that will harden critical components and key strategic assets. Irrespective of this understanding, the federal government has failed to take proper actions to protect the nation's civilian-based electric grid." So at the Grid Security Summit, what we studied for several days was how Texas could protect itself, protect its businesses and protect its citizens. There were a number of key experts and out of that came this book called "Guilty Knowledge: What the U.S. Government Knows About the Vulnerability of the Electric Grid, But Refuses to Fix". What I'm proposing and what will happen on October 24, that is a Monday night work session, will be held here in the Council Chambers and we will have three experts that will be attending to address this with us, to explain it to us because the Texas Senate has asked for our help. They want the municipalities and counties to weigh in on this because they are in the process of crafting legislation and I think it's only prudent that we have a say in how that legislation makes its way through the Senate, through the House, and eventually to the Governor's desk. To that end, I have forwarded this book. Each of our council members has this book. It's a mere 54 pages. It was written by Frank Gaffney from the Center for Security Policy. This was delivered to each council member a week ago. It's a quick and easy read albeit eye opening and shocking but it's 54 pages.

I really wanted to give everyone a chance to look at it so that they were familiar with at least a working knowledge on the topic when our experts come to address us on October 24. I wanted to just tell you who will be here so if you are interested in this topic you would be able to attend. It will be a Monday night work session. It'll be in these chambers, not over in the civic center. The three that will be attending are Ron Jacobus. He is the policy specialist from the office of Senator Bob Hall. Senator Hall would have liked to be here himself but he is otherwise committed. Also, there will be the commissioner from Harris County Office of Emergency Services District 9. He is also the president of Houston InfraGard EMP Sig. His name is Robert Janusaitis. Forgive me, there is four experts that are coming. Michael Lambert is a homeland security planner from the Galveston County Office of Emergency Management so we'll have one from Harris County and one from Galveston County and League City is his area of operation in responsibility. And lastly, Scott Tucker is an architect from Page Sutherland, Page. He has participated in EMP hardening projects and will be able to address any technical questions you may have. His expertise is on shielded facilities and all of that information has also been forwarded to my fellow council members. So everyone should have enough time to peruse it. If you have any interest in the topic, I do invite anyone at home or anyone here in the room that would like to attend. That will be in this room, these chambers, Monday October 24. There will be a presentation and then time for questions after that. Then on October 25 the resolution that has been crafted by the Texas Senate in the Senator's office will be presented to council. In fact, it will be presented to everyone, the public, and it'll be presented to council long before that, but it is a simple one-page resolution of support for a study and action from the legislature coming up in the next legislative session in 2017.

Todd Kinsey said I really appreciated Ms. Gramm's comments today with the Communities in Schools. Most people don't know that I grew up quite poor. I grew up in a house that didn't have indoor plumbing, no air conditioning, so I know what a lot of those kids are going through. That's why I've spent a lot of my adult life giving back to the community and coaching Little League, because that's where my male role models were and that's another reason why the library is so important to me. I'll run down what's going on over there real quick. We always have great events at the library. It's our most used facility in the city. On Thursday, October 13, at 10:15 a.m. Mike Conwell and Larry Watts will discuss their writing at Local Authors Hour. On Saturday, October 15, from 1:00 p.m. to 2:00 p.m., the Teen Anime Club meets in the Library Board Room and finally on Monday, October 17 at 7:00 p.m., the Book Club will discuss Golf Coast Reads Selection. Check out the library's calendar, there's always great stuff over there.

Geri Bentley said glad you're all here. Good to see everybody here today. I just wanted to let you know that this past week I was in Austin with some of our other council and staff members for the TML Annual Convention. It's a great time to meet with other cities and find out what they're doing and how successful they are. It is an opportunity for us to learn. We get a lot of education at this. Also, I had an opportunity to speak with the lobbyist for TML and give her some items of interest to our city. They are an advocate for us, for the cities and for the counties and so I wanted to make sure that they heard our concerns. I also met with a group of people vesterday with Senator Larry Taylor. We had about an hour and a half and we had quite an agenda. We had about eight or ten things we spoke to him about. My interest was city issues. He took notes, we talked to him, we had back and forth and we have an advocate there as well for city issues. Also, the young lady who spoke about the advocacy thing, I wanted to let you know that a group that I belong to for the last four years, the last four legislative sessions rather, we rented a van and we have gone to the legislature as citizen lobbyists. When we went there the first time, we had a little name tag on that said citizen lobbyist, and this gentleman walked up and he said who are you and I said we're just citizens and he said who's in charge here and I said all of us. We're all tax payers and we're all in charge of our money. He couldn't really quite understand the concept and then in the conversation I said and what do you do and he said I'm a lobbyist. And I said okay, that's why you don't understand, we are citizen lobbyist. Anyway, you're welcome to join us and that's what we do. We go and we talk to our legislators. We go into their offices. We go with a simple white paper for an issue that we are for or against and let our legislators know that we're doing that. Also, Ms. Hansing and I did attend the EMP summit. It was two days and it was awesome. If you think things like that can't affect you, everybody has one of these and it wouldn't take very much at all to knock this out. Knock out your microwave. Just imagine, anything in your house that's tied to electric, can just go away. We would be totally in the dark, so it's very important for us to back this for the legislature for the next session and come and see exactly what this is because many of us, I thought I lost my cell phone a couple of weeks ago, and I tell you I panicked because everything in my life is on this little thing.

Keith Gross said I'll be brief. Welcome to the City Council meeting. I would just like to thank everybody here and thank the mayor for making this day so special for my daughter. She's my only child so I really go out of the way for her.

Nick Long said thanks for everybody coming tonight. I'm here to invite you to the 65th Annual Junior League of Galveston County Annual Fundraiser. The Junior League of Galveston County does a lot of great work throughout the county both on the island and on the main land. They do a lot of activities with the local schools and primarily they focus on children. That's really what they do. This year the 65th Annual Ball is put on by my wife. It will be held on Friday, December 10, at the San Luis Convention Center. They are looking for sponsorships and live auction items. You can get more information at www.jlgalveston.org.

Mayor Hallisey said two weeks ago we lost Charlie Walker here in town. We send our love to Poochie. Charlie's family is why there's a Walker Street in front of City Hall and it runs down through the old part of town. Also, last Friday, I lost an old friend. Velma Smith Bradshaw Leavell was 101 years old, a significant family in League City's history. Her dad during the 1920's, a guy named W.T. Smith, was the county commissioner in the north end of the county. He was the person most responsible for making sure there was a county wide election that created Galveston County Park, which all of you know is Walter Hall Park. Velma's family was a founding family, her mother was a Brown and they were a founding family of Friendswood. She lived in League City when she passed away. She lived a full life and was full of life her whole existence here. We'll miss her. Those of you that live off of Hwy 96 who drive by Bradshaw Nursery Road, you'll know that that was her family because that plot of land that you live on out there was Bradshaw Nursery at one time in history. So we say goodbye to both of them. Also, as Ms. Bentley did, I spent the week at TML. It was kind of power packed. There was a lot going on. I will tell you, Texas is in good shape if you listen to everybody talking up there. The legislative session looks very exciting.
