I want to wish all the League City moms a Happy Mothers' Day this week, especially my beautiful wife, Heather. At the Library, the Local Authors program will be held in the theater on May 11 from 10:15-11:30 a.m. Carolyn Ferrell Watts will present the books in her "Keys to Parenting Magic" series, as well as her latest book, Dishonored and Forgotten, co-written with Larry Watts. The League City Book Club will meet on May 15, from 7:00-8:00 p.m., to discuss Hidden Figures, by Margot Lee Shetterly. The movie club will screen True Grit (2010) at 1:00 p.m. on Tuesday, May 16.

Dan Becker had no comments.

Nick Long said thanks for everybody coming out today. Also, Happy Mothers' Day to all the mothers in League City and my wife, Kari, as well, and my mom and my mother-in-law, who are all League City residents. I want to say thank you to Sandra and Mel Kelly, and especially my wife, for planning the Dog Park Fundraiser Sunday before last. It went really well, we went through about 700 pounds of crawfish. And to Yea for Life for coming out to cook that crawfish. I'm glad I didn't have to do that myself. It was a pretty impressive setup they had. Also, to the Councilmen who raised money and did a lot for it, Larry, Greg came out and the Mayor and his wife also came out. I know the rest of you will be bringing the checks to Sandra to settle up for that. A big thank you to the rest of the Dog Park Association and the kids from the National Honor Society. When we showed up there were probably 30, 35 kids from all the high schools in League City, with the National Honor Society, ready to help us set up. So I was really pleased I didn't have to move all those tables and chairs and get all that stuff done. They stayed there for five hours, they stayed there until the last piece of trash was picked up. I attended the BayTran monthly luncheon, the Finance Committee meeting, the City Council Subcommittee on the City Manager goals. I also attended the Galveston County Transit District Board meeting, League City Historical Society, which I learned a lot about the different architectural identities in our historical district by Steph McDougal. I attended the Planning and Zoning Commission meeting, 4B Board meeting, the meeting with the staff and the homeowners and learned all about PID #1 and how you terminate PID #1, more than I ever thought I'd like to know. I think that that's on the road to getting done and that was one of the tougher meetings. I also attended the Parks Board meeting and then the League City Music Festival. I spent Friday evening out there and was actually in my first parade Saturday morning and spent Saturday out there and I had a wonderful time and I'd like to thank all the Lions Club for what they did on that operation. I thought it was outstanding. I'd like to thank the City staff for what they did in relation to the pavilion they had and even for the attorney flipping burgers. Everybody had a great time, I thought it brought a lot of community effort together out there and really was well received and I was totally amazed and I'd like to say hats off to the Lions Club.

Mayor Pat Hallisey said May is Mental Health Month and Galveston County's Community Health Center, Coastal Health and Wellness is using the month to highlight talk therapy counseling sessions available to county residents. The great thing is Coastal Health and Wellness not only accepts many insurance plans, but offers discounts for the uninsured and underinsured, making mental health services accessible to more people in our community. So if you are in need of that, check with our Galveston County Health Center. I want to make a point that one of our Planning Commissioners passed away last week, Bill Arnold, and we certainly send our prayers to his wife Pam. He will be missed, he was an integral part of our Planning Commission. I want to thank Denny Holt, who many of you know, who provided a bright red

Corvette for me to ride in during the Village Fair Parade this weekend. So, Denny, if you're out there, thank you very much. I also attended a ribbon-cutting at Unity Bay Area Church on Sunday, which is down here at 1911 Hwy. 3 South. You have a beautiful facility with an old sand pit that has been beautified and they have some viewing stands out there and a brand new labyrinth. I learned all about that Sunday as well. I want to remind everybody, I won't be here at the next meeting so I'm going to do it now, to join us at Fairview Cemetery on Memorial Day where we honor those who fought and died for the freedoms that we take every day in this country. I always say about that cemetery there are 20 Civil War veterans buried out there, and veterans from every war since, so it's a nice affair and I would certainly like you to get that on your calendar. I'd also like you to mark your calendars for an old-fashioned Tuesday, July 4th at Historic League Park where all of these people you see at the table will be serving you hot dogs, watermelon, whatever else we have out there. There will be music and it's a great small town activity. If you like being part of that, that old part of town then that old League Park is the place to be on July 4th. I didn't know until today, but today is National Teachers' Day, so if you have a moment tomorrow and you missed it today, thank a teacher. They're pretty important. I was watching a video clip on Facebook last week and it was a John Kennedy speech, and he made a point of saying that when you think it's okay to pay your plumbers more than you pay your teachers, you have to ask yourself where your values are. You entrust your children to those that teach them, pretty important. We certainly want to congratulate the Clear Creek Independent School District on passing their bond issue this week. Like it or dislike it, there was a turnout and it was a sizeable win for the district. I also want to congratulate all the newly elected and re-elected public officials in the region. People who give their time to public service generally don't make much or any money at it, they do it out of the love of their community, much like Mr. Frankovich who continued to serve after he was Mayor. We're very proud of them. Yesterday was the Saul Balderas League City Police Department Golf Tournament. I heard it was pretty successful, Chief, is that the word you got? Those of you that didn't know Saul Balderas, I'll tell you what kind of guy he was. My first day in town, 40 some odd years ago, he just walks up to me and sticks his hand out and says, "Hi, I'm Saul Balderas. Anything I can do to help you, call me." And he did that to everybody that he met in this town. He's been gone for a while, but he was a great guy and we miss him and I'm glad the tournament was good. Kudos to the Lions Club. Outside all of the spectacular comments, one of the things they do out there, and they did on Friday morning, they had somewhere in the neighborhood of 1100 to 1200 special needs children as their guests at the park. 260 school buses brought those children to the park, they went on the rides, they had a great time. Whataburger stepped up and fed everybody that was a part of that. Standing at the gate when the children were leaving, the one impression that you never forget is the smile on their faces. The Lions Club, you guys, that was a first class effort. Wonderful opportunity for those people. Local Fox 26 had "Hometown Fridays" here in League City, they came to town and highlighted a lot of our assets, the Butler Museum, League City One-Room Schoolhouse, the City's history, South Shore Harbour, a lot of the restaurants in town, League Park, talked to a good number of people. Chief Warren got to talk about the new insurance rates they got with

their new rating. It was all morning long and I don't know that I understood when I showed up to talk to them, what that was all about. They promoted League City in a really positive way and so for Fox 26 News, please watch them. Maybe they'll come back. That was a terrific deal. I talked about going to the church, I've been trying to make all the churches in town. It's been a year of enlightenment for me. I made it to the Hindu Temple out on Landing Boulevard, met 500 of our neighbors. Really was fascinating learning a little bit about how they express their faith and I think most of them were doctors and lawyers and engineers. They were the nicest people, had a great meal and I hope they invite me back. We had an interesting thing happen last week. I got a call from Pastors Bryan and Natasha Young of Word Power Church and they said today is National Prayer Day and President Trump sent out a directive on National Prayer Day. So they showed up at the flag pole out here behind this building and we had National Prayer Day and prayed together at 5:00 and we all decided we would meet there next year at the same time. Pastor Young tried to get the other churches involved, but by the time he got wind of it, it was kind of late so we hope next year it will be better organized, but it's a pretty neat deal. I attended the Dog Park fundraiser as well and everything's been said except for one thing. It's easy to put on a fundraiser if you have money to do it, it's easy to have a crawfish boil if you have money to do it. I give Mr. Long and his wife a lot of credit because they didn't just talk the talk, they walked the walk and they paid for all the expenses, crawfish and the other things so that the Dog Park Association could have their fundraiser. So, Mr. Long, kudos to you. I will say this about the League City Music Festival, Justin, Sebastian, Jason, Greg, Cory, Walt, Trey and the people I can't remember, that I met, the Village Fair has always been, probably the biggest activity we have in town. You do promote and give a lot of money to people within town, a lot of money to the Lions Camp for Children and I think this had to be probably the smoothest, I agree with Larry, one of the smoothest run, everything went off like clockwork. There were no negatives out there at all, the music was outstanding. I enjoyed Jake Worthington, and I enjoyed Tracy Byrd. I enjoyed the first two songs of Eric Paslay, but I had to go home because I go to bed early. It seemed like all the young people in town were having a grand time. City Manager John Baumgartner said we've had a lot of public input regarding IH45, the construction ongoing out there, particularly the interchange with SH96 and IH45, TXDOT preparing to widen the bridge over SH96. They've closed a number of lanes out there. Our Public Works staff has reached out to TxDOT over the last several days and has persuaded TxDOT to alter their traffic control plan, perhaps provide some relief, not total relief, the way it was. Over the next few days we should see some of the closed lanes open back up and hopefully provide a little bit of relief. We've worked pretty hard with TxDOT on managing the traffic signals. There is still some work to do. They've taken a single signal controller, put two in there. They're not synced very good and the residents, particularly on the west side of town have experienced a lot of frustration getting from their homes to IH45 and on by IH45. So hopefully over the next several days we'll see some relief over there.
