On a little bit more serious note, I didn't speak on the item about the board appointments but it was a split vote so I think it would be good to get my thoughts out there. For me, having served on the Planning and Zoning Commission during a somewhat tumultuous time, I have a unique appreciation for all the volunteers in the city who serve on our boards and commissions and I tend to err on the side of giving people who apply to serve on those boards and commissions the benefit of the doubt. We have a set of standards in place and as long as applicants meet those standards and they have a mayor or council sponsor, I'm inclined to support them as well. I don't think that all of our board appointments are perfect, I don't think that any of us sitting on council are perfect. I know I'm not, but I do want our board members and our commissioners to be qualified and to have a diverse perspective. That's my thoughts on board appointments. I also want to take this time to say thank you again to everyone who does serve in some capacity as a volunteer for the city because what makes League City the greatest city in the world is its people and we wouldn't be who we are and where we are today if it wasn't for all of you, so thank you for what you do and I hope we get it right more times than not.

Greg Gripon said I hope everybody is having a wonderful summer. It's been a lot of fun so far. I attended the Harris County Mayors and Council Association Boat Tour of the Houston Ship Channel. It was a lot of fun going for a ride down and seeing all the ships and it was kind of eye opening too. They're pretty large. Tomorrow League City will be hosting the Galveston County Transit District Board meeting right here. This coming Sunday, the League City Lion's Club will be hosting its monthly senior breakfast. That means, Larry, you can attend and so can you, Mayor Pat. On Monday we're going to bring back fireworks to League City. We're going to have live music, food trucks, moonwalks, vendors and we're going to have fireworks. This is at the Sportsplex coming up on Monday. On Tuesday, July 4, we're going to have our Citizen Appreciation Day at League Park. I'm going to be there serving hot dogs. Come out, bring the family and make it a great family day.

Larry Millican had no comments.

Mayor Pat Hallisey said I agree with Mr. Gripon, one of the things that makes this community really great is that there is a small-town feel. We live in a large town, you all know that because of the traffic that you endure every single day, but we do have a small town feel and I think all councils since the beginning have worked hard to keep that. Where you see that illustrated at its best is going to be on July 3 at the Chester Davis Sportsplex when we have a fireworks display. That's the first fireworks display I ever remember in town so I think it's a significant thing. Kids love fireworks, parents love fireworks, scouts love fireworks, and I hope all of you come. There will be food and live music. Billy Miles and the Miles of Texas will be there. He works for the City. Great country music. The next day, July 4, will be our traditional July 4th activities at the park. I think last year there may have been two to three thousand people. We're hoping to double that this year. There will be music in the park and as Mr. Gripon pointed out, we will be serving hot dogs. I hear there will be watermelon served like we did last year and it's a good opportunity to meet your neighbors and I hope that those of you who are homeowner association presidents or involved on the boards, that you make sure that gets out to everyone. I also want to tell you that on the 4th of July at 10:00 a.m., the League City Historical Society will have their annual Teddy Bear Parade. It's the cutest thing you'll ever see. All the little kids under 10 years old with their wagons dressed up in Victorian outfits to current outfits. There are a lot of kids that participate and if you have children under 10, you can be at the One Room Schoolhouse on Kansas Street at 10:00 in the morning and they will sign you up. I believe it's free, I hope. Tell them I said it was free. On some sadder notes, last week James Davis, who was a city council member in this city at a very significant time back in the early '70's when this complex was built, passed away. He was a long-time realtor in the area. He was a great guy and we send our prayers to his family. Also, this morning we learned that Bill Ludwig passed away. Some of you may know Bill from Ludwig Catering, that he started a good number of years ago, but Bill started his career in League City as a postman. He walked the mail all through the neighborhoods. He was a bit of a character if you ever met him. You could go to any grocery store and he would be holding court, telling people about how it was when he was younger. His wife,

Dorothy, survives him. She is a Ghirardi. Many of you have heard about the Ghirardi oak that the city tried to save. She and her sister that owns Gay Pontiac, Marie Gay, are Ghirardi sisters. They are pretty much the last of the family. The brothers have passed away. They were part of the original 10 Italian families that migrated to League City in the 1880's. Getting to be the end of an era. Also, we send our prayers to Fay Stelly, whose husband Ed passed away this year. Ed and Fay bought and planted the Christmas tree that you come to every year out here in front of the library for our Christmas festivities. Sweet people. They still have children that are in the area. We send our prayers to all of them for Fay who's not doing very good. Those are my difficult things to get through. I want to wish everybody a very happy 4th of July. We live in the greatest country on the face of the earth. We're not perfect but as I said earlier, God forgives us for our sins. We're happy to be here and whatever mistakes we do make, this system has withstood almost 250 years. God bless everybody and have a good time on the 4th and we'll see you in the park.
