#### 7. COMMENTS/REPORTS FROM MEMBERS OF COUNCIL

Announcements concerning items of community interest. No action will be taken or discussed.

Larry Millican said welcome everybody for coming and those at home, welcome and thank you for attending. I would like to talk about transfer of information tonight. We sit up here before council, we get a tremendous amount of information that we need to disseminate before we actually rule or pass on anything that we do. Let me say that this week's package that we needed to read and decipher was 648 pages. Last council meeting was 676 and anybody who has listened long enough understands that we have a lot of questions even after getting that amount of pages to where we can get to pass a decision. I think that where I'm going with this is that I'd like to have, if I could, some input in the decision-making process from the citizens.

I know that occasionally we have people come here and speak to us but there are a lot of ways that people communicate today, not just coming up here and speaking at the microphone. I know that my business card for the city, along with the website, has my cell phone on it and I would like to hear from each and every person that has an opinion about something in the city that might deal with the activities around what we're rendering decisions on or trying to make decisions on, is that we go through a lot of processes to just buy automobiles. It's unbelievable the amount of information that's done just to replace automobiles in the city and we have a fleet that's quite large, it's very massive. We had an item on this agenda that talked about compensation and the compensation study and all that went into it and I think that when you start looking at this information and disseminating it, while we all put forth a lot of effort taking this information in and making decisions, a lot of times I question if the average citizen actually understands what's going into making these decisions and how to get that information and I'd like for one to understand where you do get your information and how you process it and if there's any easier way to get it if you do want to get more information to understand what the process is to replace automobiles or for that matter, we have an agenda item tonight about voting for board members on the Central Appraisal District and how that happens. I can tell you that there's a tremendous amount of information in our data sheets. Those are available. For six years while I sat out there with Peggy, I went to the website religiously every council meeting and pulled off every data sheet and read every data sheet but trust me they don't tell the entire story. They don't give you every bit of information. That's the reason we ask questions up here at every council meeting so that I want to know what's important to the citizens. If you're doing a good job, the citizens don't show up and they don't call you. I think that it's more important than that. I'd like to hear from the citizens. I'd like the citizens to tell me or tell the city what they would like to see in information transfer. How in depth do you want it because these 650 pages that we received as council people, you as a citizen have the ability to go right to the website and pick off every one of those 650 pages. I did it for six years. But again, how many people want to do that. How many people care about it and I say care. Care is a word that I hold very dear. I think that I get enough opinions. Not a week goes by that someone doesn't ask me about the city, that they don't ask me about decision-making processes, but after I explain I guess they're satisfied. They don't call me anymore or talk to me anymore about a particular topic. I would like to know if the citizens are concerned about the same things that we are. We try to build this package to where we don't have any more questions and we can pass a consent agenda and we can pass items, but it's very difficult. How much information do we need? How much information do the citizens need to make sure that they understand that we're doing an adequate job for them. Politics is something that I don't think I'm a politician and I don't care for politics as a whole. I worry about the transfer of information, how the citizens can tell us if we're giving them the right amount. How we can do a better job? That's what I would like to challenge every citizen out there listening that's in the audience tonight if there's an idea or a thought process, give me a call, I'm ready to listen.

Greg Gripon said good evening. I hope everybody had a wonderful Thanksgiving. Always a wonderful time of year. I guarantee I've put on a few pounds. Today is "giving Tuesday". It's one of those things that once a year "giving Tuesday", what is that? Well, let's talk about giving to your charities. I'd like to see everybody give year around to their charities because our local charities here in town really make our town and make wonderful things happen in our town so it's always good to give to our local charities. Also, it's very good to go to the local restaurants, shop at the local stores. It's very important to keep those tax dollars in League City. The League City Lions Club will be having its monthly senior breakfast this Sunday. We'll be up there early cooking breakfast. On our Mayor, he's doing very well. Looks like he'll be coming home this week so he's really excited about that. The prayers coming out for Pat have just been so wonderful. Thank you. I've got my holiday tie on here so I've got to put a word in for Holiday in the Park. The parade is this Saturday evening. Hope to see everybody out there.

Keith Gross said good evening and I'd like to welcome everyone to this League City council meeting. I want to remind you that we are having the lighting of the Christmas tree this week and the Christmas parade is coming up but I know Councilman Long wants to talk more in depth about it so I'm going to yield the rest of my time to him.

Nick Long said Mr. Gross saw the thing and stole my speech before I got up here but I do have something else prepared. I saw an interesting article of the 500 largest cities in the United States. League City will spend the second most per capita on the holidays. That's pretty amazing. Number one was Sugarland, by the way. So that's over \$2200 per household so I would encourage people that are spending some of that \$2200 to spend it here in League City with our local merchants. Resist the urge to go to Amazon or drive up to Baybrook. We have the stuff right here in town as well. Now for the details on the Christmas tree lighting. It's on Thursday, November 30. The open house starts at 5:00 p.m. to 6:30 p.m. Santa is getting there around 5:00 p.m. And then after the open house at 6:30 p.m. the tree lighting will be out front at the big permanent tree out there and it's all sponsored by the Knights of Columbus, the City, the Library and the Parks Department. If you've never been, it's pretty neat thing. It only takes maybe an hour and it's really a neat time, kind of that old time, old town feeling. My kids like it every year. Warning, if you want to get a picture with Santa Claus with the kids, you better be there at 4:30 p.m. because Santa is incredibly popular and it gets really busy.

Hank Dugie said thank you, Mr. Kinsey. Mr. Vaughn, I had a very wonderful Thanksgiving. Thank you for asking. I hope everyone else out there had a wonderful Thanksgiving full of food and family. Maybe a little bit of football. I'm going to echo what Mr. Gripon said, come out to Holiday in the Park this weekend. I will be walking in the parade, passing out candy and I promise I will try to ration it so that I have some at the

end. For those of you who go to parades frequently you know that it's very difficult to ration candy when there are kids running at you asking for it. If you're going to come to the parade for the purpose of candy, try to get towards the front and that's where the best candy is.

Mayor Pro Tem Kinsey said I will tell you that the Christmas parade is the most awesome event that the city does. I absolutely love it. It's my favorite event of the year. Everybody else has really covered that. This is a busy week with that but I will say over at the library this week they are hosting their volunteers event so if you've ever been interested in volunteering at the library and getting involved there, their open house for that is going to be on Tuesday, December 5 from 5:30 p.m. to 6:30 p.m. in the Library Boardroom. Just ask at the front desk and they'll send you. There's going to be a tamale taste-off and a chance to meet with our great city librarian, Ms. Jenny Brewer, and you'll be able to apply on the spot if you want to be a volunteer. And finally, on Thursday, December 7 from 6:30 p.m. to 7:15 p.m., Holiday Fun with Dan Brinkman, there will be the what they call the Jingles Magical Workshop Tour in the theater and that's for kids 3 to 8 years old.
