Announcements concerning items of community interest. No action will be taken or discussed.

Hank Dugie said thank you everyone for being here.

Larry Millican said I would like to welcome everybody here. I think walking through the audience this evening, I was amazed to see how many people did come off of the announcement for the downtown district and I'm very pleased with the participation and I welcome everybody here.

Greg Gripon said we had a grand opening of the Bark Park at the Gripon Park and let me tell you what, I was extremely impressed with all the citizens that showed up with their dogs. Now what was really neat was when we opened those gates and they ran in, it looked like born free. Dogs were jumping and running. Not a single fight out there. They were having a great time. Kudos to Sandra, the Parks Department and any staff that worked on that. Fantastic job! It looks like the citizens definitely have spoken that they want a dog park. Also, I attended this last week the Galveston County Mayor's and Council meeting. It was held right here in League City at Butler's Courtyard. We had a great time talking to all the rest of the council and mayors in Galveston County.

Keith Gross said I just want to reiterate what Councilman Gripon said about the dog park. When I had voted in favor of this, I had no idea that 3,000 people would show up with their dogs on the first day. It was an overwhelmingly big hit. Sandra, you ought to be commended for orchestrating and taking charge of that. Thank you very much, I'm sure, on behalf of everybody in League City. I want to say thank you to the Parks Department and everybody else who worked on the event. It was truly fantastic.

Nick Long said thank you to the Parks Board, to Sandra, and most of all to the city staff because for those of you that don't know the history of that park, it used to be a water/sewer plant, just kind of a nothing piece of land that wasn't doing anything, we allocated \$150,000, which if you know anything about government projects that's not even any significant amount of money at all, it's just a rounding error, and they took that \$150,000 and the staff worked so hard to leverage that money and came up with something truly great. Of all the events I've gone to in the city, this is probably second only to the Fourth of July events in which the excitement and the desire for it and to really put that on and everybody to work together and it was really awesome to see that. Lastly, at the Mayors and Councils event that was held in downtown League City, I heard from some of the other elected officials around Galveston County that they had never been to this part of League City. It's really cool. I thought League City just popped up like ten years ago and there's no history at all so it was really neat to see those people get exposed to a different side of League City and I'm hopeful that we can get even more people exposed to that in the future. Thanks.

One of the most touching things I've seen in my life was when Janice stood in front of the lectern with Mayor Hallisey on FaceTime so that he could participate via video. It just really hit me in the heart. It was just an amazing thing to see. Kudos to John and the parks staff for putting on two events this weekend so the Parks team was really busy. We also had the Veteran's Day ceremony on Saturday. Outstanding weather for it for the first time in a couple of years. The last couple of years it's been windy and rainy so we had great weather. Myself being a veteran, it meant a lot to get to host the Veteran's Day ceremony for the first time. Just real quick, going on at the Library since that's always near and dear to my heart. Our Funtastic Farm Program will be on Wednesday, November 15, at 10:15 a.m. in the theater. There will be video games and board games on Friday, November 17, from 4:30 p.m. to 5:30 p.m. in the theater and finally on November 18 from 1:00 p.m. to 3:00 p.m. in the theater they're having an event called Library History Focus Group and residents are invited to come in and share their story of the Library's early years. Again, League City is trying to rediscover its history and the history department at the library is an amazing part of the library to check out if you're a history buff. Other than that, after Thanksgiving we'll have a tremendous amount, all my favorite events of the year coming up with the holiday parade, and everything, but I want to wish everybody a happy Thanksgiving and a safe Thanksgiving.

Then a couple of construction projects we've had a number of questions on, one of those is South Shore Boulevard and State Highway 96, we're building some dual left turns out there and the project appears to have stalled to the public. We understand that. As we started our construction project, we thought we had our plans approved, well we know we had our plans approved, and TxDOT said that the section we had proposed has failed in some other location, asked us to revise that. There's a change order on tonight's council agenda. If that gets approved, we should see the contractor back out there back to work, get that thing completed, buttoned up, and provide some traffic relief out there. The other one that we've had quite a bit of comment on is the new traffic signal at Austin Street and FM 270. We are waiting on final approval from Texas-New Mexico to provide the power to that location and a meter. In the days before deregulation that was easier and for whatever reason, it seems to take longer than it should and we're working our way to get that done as soon as possible.
