Mayor Pro Tem Todd Kinsey said learn about electricity and engineering over at the library. The Snap Circuits® will be over there this week for those that are interested in science technology, engineering and math. That will be on February 28 from 5:00 p.m. to 6:00 p.m. in the theater. This program is especially for kids from ages 8 to 13. Our Science for Little Explorers program on March 7 from 10:00 a.m. to 11:00 a.m. Children will learn about magnets doing hand on activities. Finally, new this month, a local crafter will be helping adults and teens create simple handmade cards using paper cutting techniques. That will be on Tuesday, March 13 from 6:30 p.m. to 7:30 p.m. in the theater at the library. Hank Dugie said thank you, Mr. Mayor. I guess if you were going to miss one of the three speaking items, the one to miss would be the city council one so do not worry about that one. That being said, I will be brief. I did want to point out that Officer Griffith who was just awarded one of the tenure awards, was my D.A.R.E. officer when I was in 5th grade so that tells you about how long he's been here. So, Officer Griffith, if you're watching from home, which I'm sure you are, thank you for all you've done for the community and what you did for me as a 5th grader. On that note, people ask what the role of a public servant is, what the role of city council member or a county commissioner is, it's really hard to sum up one item in particular but I do think one of the most important things to do is hire the professional staff to get the day to day job, the day to day work done, and I just want to thank all the staff, Mr. Baumgartner and his whole team, for everything they do for us. And I want to remind the citizens who are watching, that we really do have the best in the business when it comes to customer service, and if you ever have a need, a question or concern, this is the team that can get you those answers and they are more than happy to get you those answers, so John, thank you to you and your staff and I look forward to continuing to work with you.

Larry Millican said I would like to thank everyone for coming tonight and everybody tuning in to Channel 16. I'm looking forward to the spring and the summer in League City. I'm real excited about the future of League City. The City Manager has engaged a consultant to help with the strategic planning retreat for the council and the directors. The City Manager has also planned all the workshops for the budget and the CIP this year in the summer. I can tell you, with this type of planning and this kind of attitude, I believe that great things are going to be in store for League City and I believe that League City's future is bright and I'm looking forward to helping the city any way I can. Thank you.

Greg Gripon said good evening and glad to see you all here tonight. Obviously, you all did not have Garth Brooks tickets. There is a story behind that, but we don't have time for that tonight. I'm going to give you an update on Mr. Elementree. So far we have raised \$4,537.03 which is not nearly enough to move the tree but it has definitely brought awareness to the fact that we need to look at our tree ordinance. Many people gave a lot of money and it's greatly appreciated. This money will be spent, through our Patrons of the Park, will be spent on the oak trees along Main Street. They need a lot of care. They need fertilization. They need pruning. That will keep the health of these tree looking beautiful. I understand we lost a tree earlier today and I really believe, if we prune these tree, fertilize them, we may not have had that tree that went down today. The care of these trees is very important on Main Street and in League Park, so we tried and I want to thank everybody that gave.

Dan Becker had no comments.

Mayor Pat Hallisey said Councilman Gripon, I've been thinking about Mr. Elementree all week and there are people like you in our community who will extend yourself, put your money on the line, organize people to try to save what's our heritage in this town. We have been this city of shady oaks, and friendly folks, but those trees are important to our heritage and you never can tell what's going to happen. All you can do is try. Almost a quarter of a million dollars is a big chunk. We've had fundraisers in this town for a quarter of a million dollars several times, once for a liver for a little girl. We've figured out how to get our hands on enough money to save the last tree and it was out on FM518. I personally thank you. Your father is smiling down on you right at this moment because you are carrying on the legacy that he began here, so thank you. Chief, I'm embarrassed to say that I cannot remember the animal control officer's name, but yesterday my wife was rushing me home so that I could get up to Houston and in the middle of Williamsport was this snapping turtle. From tail to mouth, it was this big, and it looked like somebody had run over it's shell because it was caved in and Janice just wouldn't quit. She called animal control and all the officers were tied up but the guy who answered the phone, I wish could remember his name because he deserves an attaboy, showed up out there and saved that turtle. We got the cars out of the way but he saved that turtle. He brought it right up next to my window and when that sucker opened that mouth, I could see why they called him a snapping turtle because whatever he closed on probably was staying with him. If you could look in to who that is and thank him personally for me. Janice, is watching tonight and if I hadn't brought that up I would've been beat up. We spent this morning with our Chamber with one of our newest members, it's called Kemah Palms. It's an addiction center on Delesandri Road, where they deal with drug and alcohol addiction and try to bring people back. As most of you know, addiction destroys families. All across the country there are different types of it but the most commonly known is alcohol and drugs but there are people addicted to eating and all kinds of obsessive compulsive behavior. I was happy to see this place open its doors and I hope that people listening out there on the televisions tonight may have a need for that or if people come in and out of the police department that you know that there is a recommendation of where to go to try and get some help because we can't continue to putting our future into the jails. Young people sour when they're in jails and they sour when they're in prison. Let's help them before they get there and if it's a matter of going to a treatment center then let's recommend them to it. I was really proud to be out there today. I echo Councilman Millican's comments. I think what's going on in this town is great. Somebody asked me today how have we done after the storm and let me put it this way, I think our spirit is coming back. You can see it when you talk to people in the community. City Manager Baumgartner and I told people a month and a half ago, we were going to try to find solutions to their drainage programs. There are a series of public meetings, please check the web page, that are scheduled where those of you in Bay Ridge and the other communities that were affected so dramatically will be able to come and listen to what the results of the engineering study is and I have to give, irrespective of it being election time, the county government put out for bid, the cleaning of Gum Bayou. I don't think Gum Bayou has ever been clean all the way down to Dickinson Bayou in my

time in League City. That's a big job. It's going to cost a lot of money and I'm proud of the court for recognizing the problem that it caused. My guess is it was probably Commissioner Apffel leading that charge since that's his precinct over there. We're happy to know that and hopefully the money that we spend will help water get to Gum Bayou quicker. What we don't want is it backing up into people's houses. That's a tough deal. I think most of the people around town are well on their way to recovery. For those of you that have never been flooded, it's a catastrophic event for your family. I applaud John and the staff for getting the engineering studies done. We have six underway and we will be reporting to the public on what can be done in their neighborhood. If you want to know, call Mr. Baumgartner, he's here all day. That's all I have. Thank you for being here.

John Baumgartner said I appreciate your kind words. Our organization is comprised of great people, great people help city manager's get the work done as you saw tonight with the four individuals who have devoted over half of their lives to support League City and they keep working away, working on 30 or 35 years of service with the community. We do look forward to meeting with the community. Bay Ridge is the first neighborhood meeting scheduled to talk about potential solutions on March 22 at the Civic Center. That's the first of a series of meetings. Again, I look forward to working with the community to make sure we didn't miss anything, to make sure we understand the depth of the problem, I think we do, and then set up a path forward as we go, as we look at the results of that and bringing those to council as we work our way through how we are going to fund them and through next year's budget.
