Announcements concerning items of community interest. No action will be taken or discussed.

Mayor Pro Tem Todd Kinsey said I had the honor last week to represent the City at Houston State of the City Address. That was really an impressive event. It was at the Hilton America's. I was able to sit with some other mayors and mayor pro tems. Houston put on quite a show. All I have other than that is the library. On Wednesday, May 9, from 4:00 p.m. to 5:00 p.m., a representative from the Texas Gulf Coast Medical Group will be there discussing practical medical reform for families. This program is free and open to the public and will be in the Library Theater. English Conversation Practice will take place on Monday, May 14, from 6:30 p.m. to 7:30 p.m. in the Board Room. This program is open to adults of any English skill level. Finally, the Friends of the Helen Hall Library are sponsoring a Community Garage Sale on Saturday, May 19 from 10:00 a.m. to 2:00 p.m. All proceeds will benefit the Friends and help support the library.

#### Dan Becker had no comments.

Hank Dugie said first off everyone thank you for being here or for tuning in at home. I still hear that our Channel 16 viewership is increasing every week so that's good news. I'm not sure about today with some of the connectivity issues but maybe next time it'll go up. That all being said, we had a wonderful event in League City over the weekend. The event formerly known as the Village Fair, now days is known as the League City Music Festival and Barbeque Cookoff. I just wanted to say thank you to everyone who was a part of the event, either as a volunteer or a vendor or a sponsor or even those of you who came out and attended and enjoyed it just as a participant because all the money and efforts that are raised during that weekend go to local charities and they allow the Lions Club to send students from the community to Texas Lion's Camp where they have the opportunity to participate in activities that they might not normally be able to participate in. We all had a great time over the weekend and it's all for a good cause, so I really do appreciate everyone's involvement and I know that the Lion's Club will probably be starting on the 2019 festival here in the next month or two so be looking out for that. The Salute to Heroes event was a great event. Always a good time over at the South Shore Harbour Resort and I am really appreciative to be a part of this group and to be able to represent this city at those type of events.

Larry Millican had no comments.

Greg Gripon said I guess I'll say ditto to everything Hank just said. I will say this, it was a wonderful event. The weather was fantastic. We had 97 barbeque teams out there. It was amazing. The event has just really grown. It's really one of those League City proud things. I'm excited to see the future of the event grow even more.

Keith Gross said good evening, Mr. Mayor and good evening everybody. I just want to thank the Lion's Club for putting on such a wonderful event. It was truly a fantastic time. My wife and my kid and I go every year and we love it so thank you much.

Nick Long said I got to attend the Galveston Tourism Summit which was very interesting. They reported that there's more record number of visitors that went to the island this year and pretty much every single one of those visitors had to drive through League City to get there. So it kind of underscores when they're seeing literally millions, I think the number is almost eight million or nine million, it's a lot. When those people are driving down Interstate 45 we have an opportunity to capture some of their spends, some of their revenue, here in League City. So it kind of underscores what that opportunity really means to us in the long term and as Galveston grows, they might serve as a magnet but we have a very good opportunity to pick some up here. Also, speaking of the trash, we talked about this last time. I think we have heard you. The city staff is working diligently to look for options to explore changing or possibly looking at something for Saturday pickups but the first thing you do is you have to figure out what this would all cost so the staff is working that out. They're going to bring that back to city council soon and then we will have an open discussion with that within the next couple of weeks. And lastly, good luck to the League City Hooks. Today is their opening day of their playoffs for the seven-year-old League City Little League baseball playoffs. It starts at 7:45 p.m. I am the first base coach, which being a seven-year-old first base coach is not the hardest position in the world so hopefully we can knock this out, get our business over, but if not don't steal without me there.

Mayor Hallisey said May is heart month, is that correct? Early this morning, at the behest of our Chamber of Commerce and our CEO and President, there was an American Heart Association kick-off over at the U of H Clear Lake which I had an opportunity to speak about my two heart attacks back in October and I just want to say this about it because it was the undercurrent of my talk. All of these items are preventable and I think for the other speakers there this morning it was important to say that they are preventable. There are ways that you can prevent heart attacks and strokes but the first thing that has to happen is you have to take your own responsibility for your own body and you have to tune in to what's going on. I encourage everybody here tonight and everybody that's listening at home, please check the American Heart Association website so you can find out what the symptoms are so that if you're in that situation you can identify it rather easily. I also want to say that I really appreciate the Chamber. We talk about the Chamber being a business representative of our business community but I think what happened this morning was a great opportunity to talk about our community health. Steve Paterson, I applaud you and I applaud all the people that you have that put that together. It was a good turnout at U of H Clear Lake. Tomorrow night is the American Heart Association Run Kickoff. That's at Ellington at the Lone Star Flight Museum and I think that starts at 6:00 p.m. for anybody that's interested in making it. What they didn't say about the Salute To Heroes is that there was a lot of money raised for veterans that are returning. We all enjoyed the Bellamy Brothers. Most of you in here are probably not old enough to remember who the Bellamy Brothers are but some of us are. We enjoyed their music. They put on a nice show. It was a nice get together and they raised a lot of money

for veterans that are coming back to our community. A couple of things that Lion Greg did not say and he'll be beat around the head and shoulders when he gets home tonight, when he talks about the future of what was the Village Fair which has become the Texas Music Festival, I'm impressed that the two chairmen of that this year, one of them I think is 26 years old, the other one I think is 32, Jason Long did the barbeque cookoff. He was the chair. As they said earlier they had 95 teams out there. That was a turnout and if you have not been out to that cookoff, you really ought to go because it's a show in itself. Not only are people having a good time but the decorations out there are pretty phenomenal so kudos to Jason. Good job on that. The entertainment was phenomenal. The booths were phenomenal. Justin Gripon, Greg's son, was the chair of that. The Lions were out there working for the good not only in this community but they raised a lot of money for the crippled children's camp in Kerrville but they also raised a lot of money that they reinvest back into League City. I'm sure you'll pass this on to them at the next meeting. We're very proud of everybody. It was a great event. I echo Mr. Long's comments on the trash. John is working that out. He'll be beat over the shoulders by the next person that calls and screams at me because I will send them to him. Anyway, there's some interesting discussion we will be having on that. Cindy Rohan, who lives in League City, who is a stewardess for Southwest Airlines was in New York vesterday morning was in her hotel room and did not make the call to get on her airplane to provide the service that she provides. They found her in her room. She had a brain stem bleed that was pretty horrific. I think her chances of recovery are probably pretty slim but if you have a moment to think about Cindy Rohan in your prayers tonight please do that. She is married to Bad Bob Rohan and if you follow country music, he's probably as good a fiddler as you'll find anywhere and they live out in Tuscan Lakes. We're proud of him and we're praying for Cindy. Life is so fragile, you just never know when these things can happen to you or to anybody else.

John Baumgartner, City Manager, said I would like to thank the community tonight for the kind words they had about staff, Ms. Whitely and Mr. Jackson. It's a real pleasure to work for this community and serve the community. We appreciate the comments you have that are positive in nature but with that, when you see something out in the community that is not right obviously, give Bo a call or Jody a call, that would be safe way to get things done and accomplished quickly. Not that I wouldn't do that because I would give those to Bo and Jody but without great people working for the City, and it's not just Bo and Jody, we had the public service recognition tonight, it's all the employees that work here. They make my job easy, they make my job successful. I appreciate their efforts. I know that the community does too by the comments we had tonight. We're not perfect but our goals are to provide world class customer service. We try to do that each and every day. If we make a mistake or we have a service issue that we need to correct we will do that with a pleasure and a smile on our face and work to improve for the next time. Anyway, I would like to thank the community for that. As it relates to trash, we are working through some options with our vendor. Hopefully next week we will have some pricing which we will obviously make communication with the council and the community a challenge as I have talked to AmeriWaste, to make changes is going to cost some money and we'll have to have that conversation going forward and so we've heard the community and we will continue to work on that and bring information back to the community and the council. With that, I would like to have Sarah come back up and talk about a new program, one of my favorites, League City Love and she's going to give us a brief outline of what that's about.

Sarah Greer Osborne, Director of Communications, said if you were out at the League City Musical Festival this weekend, we actually debuted our new social media campaign called Share Your LC Love For League City Love. We developed this because we wanted a way for our residents and for those visiting League City to interact and share their feedback with us so we kind of formed what we call the communications street team. We had a booth this weekend on Friday and Saturday at the League City Musical Festival. You're going to see us at a lot of events in the future and folks were allowed to share with us what they loved about League City. We had great success with that. The promo video that we did had over 700 views. We had 77 pictures posted and reached about 7,000 people. On Twitter we heard about 13,000 impressions over two days on both Friday and Saturday and we just put together a little video to show you so you can see what folks were sharing with us on video and they also could hold up a sign and talk about what they loved about League City. We had a lot of people come up and take photos with us, kind of overwhelmingly the people loved the parks, they loved the people which I thought was a great answer. We will be at quite a few upcoming events. We will be at the Hurricane Fair this Saturday, the Helen Hall Library Garage Sale, quite a few HOA meetings, I'm at one tomorrow night for CenterPoint. We plan on going out to Hometown Heroes Park during the week and sharing our LCLove and of course, the July 3rd fireworks show that's coming up. You all have a t-shirt. If you need more, please let me know. I consider t-shirts kind of walking billboards so please wear it out and about as you are in League City and

encourage folks to continue to use that hashtag #LCLove on Twitter, Pinterest, Instagram. I know Councilman Dugie you're a big fan of Snapchat so we actually had a special filter so we had about 200 folks use that filter with over 2,000 views of those photos so we'll be doing that a lot more as well.
