Hank Dugie – I have great news, a couple of items the rest of you should know. Astros swept the Indians, Longhorns are ranked No. 9, Aggies are ranked No 2,. and the Texans also won. So it was a good weekend for Houston, Texas sports, and as you heard earlier today, I was elected the chair for the Dickinson Bayou Watershed Steering Committee. I'm excited to bring some energy to that group. I'm an advocate on behalf of drainage projects that affect people in League City as well as our neighboring cities. There's a lot of exciting projects coming up that could have drastic impact for the area, one of which is a possible underground tunneling system for conveying water from north of League City out to the bay. We're still investigating, but it's very promising. The thing that's most exciting to me is if we keep doing what we've been doing, we'll keep getting what we've been getting, so someone's got to change something somewhere if we want to have a different impact. So, I'm excited to see the new ideas come up and I'm hoping that at least one of them will come to fruition and have a future benefit for the citizens of League City.

Larry Millican – Welcome everybody here and at home. Thanks for joining us tonight. I've just got a short comment, that over the last couple of weeks I've been talking with Harris County Flood Control District about their bond issue and what that means to Clear Creek. And to my surprise, we have about 20 projects on Clear Creek south of that line in the sand from Brazoria County into Galveston/Harris County. It's going to be using to de-snap and clear that embankment south of Pearland that was unknown to anybody, but I do have a list of those projects and will be getting with City staff and further investigation through the Watershed Steering Committee. But it looks promising that we'll be able to actually see some relief with some of that bond money that was asked of the north of us.

Mayor Hallisey – I visited this morning with Joyce Abbey. It appears that between now and 2022 is the 60th Anniversary of NASA, which there will be a multitude of activities taking place all across our area, the Clear Lake area. It's the 50th anniversary of the Apollo program and there'll be lots of activities that are taking place for that. I want to thank the Chamber and the Republican Women, in particular, for having candidates forums. It's hard enough and darn expensive to get word out through the community, but we've done that. Impact Newspaper over there did a piece on everybody that was running, so we appreciate that. The League City Leos, as many of you will recall, young lions between the ages of 12 and 17, leadership training. They are having their charter night Tuesday, October 16, at Hometown Heroes Park from 6:30 to 8:30 and if you have children that age, please give them an opportunity to be part of that. Saturday night at Hometown Heroes Park, I seemed to be in the middle of a Indian celebration that's take place across the world. I couldn't tell you exactly what it was, but there were 600 to 1000 Hindus dancing and young people having a great time and it's consistent with my belief, if we're going to have peace in the world we have to accept the cultures of some place other than those that just look like us. And it was really a rewarding opportunity to do that. I will mention that tonight is the one year anniversary of the loss of my leg and my Life Flight trip up to Memorial Hermann. It doesn't seem like it to me either, but it's been an interesting year.
