Overview of Master Plans

- Projected water demands and wastewater flows (5, 10, and 20 year)
- Identification of existing and future system deficiencies
- Prioritized, phased CIP with cost estimates and business case for recommended projects
- Very clear, easy to read CIP maps that show location and phasing of projects
- Comprehensive Master Plan Reports

Existing Water/Wastewater Systems

- 3 Interconnects
- 10 Booster Pump Station
- 3 Elevated Storage Tanks
- 500 miles of Water Pipes
- 2 Water Reclamation Facilities
- 74 Lift Stations
- 340 miles of Wastewater Pipes

Demand and Flow Projections Existing Population (2018) 102,635 Projected 10-year Population (2028) 142,091 Projected 20-year Population (2038) 206,827

System Evaluation Criteria

- Texas Commission on Environmental Quality
- Texas Local Government Code

Water - Chapter 290

Wastewater - Chapter 217

Water – Minimum System Pressure = 35 psi under normal conditions Wastewater

- 217.53(j)(3) that "an owner must ensure that the collection system has capacity to prevent a surcharge"
- 217.61(c) that "the firm pumping capacity of a lift station must handle the peak flow"

What are Capital Recovery Fees (CRF)?

One-time charge assessed to new development for a portion of costs related to specific capital improvements. Systematic, structured approach to assessment of fees.

Types of Capital Recovery Fees

Roadway, Based on size and type of development, specific location (service area), Collected at time of building permit.

Water & Wastewater – Based on meter size, Collected at time of connection to system, Collected and applied citywide.

Both types of fees are calculated based on Service Units – units of development brought online

What can CRF's pay for? Construction, Surveying, Land Acquisition, Debt Service Engineering (included in the Capital Recovery Fee, Capital Improvement Plan

: water supply, treatment, and distribution facilities

: wastewater collection and treatment facilities

CRF's can also pay for required updates to the fee schedule, CRF CIP (not staff time, but contracted study updates)

Develop Water/Wastewater Master Plan CIPs

Develop Capital Recover Fee CIP (CIP: Capital Improvements Plan)
