Mayor Pro Tem Todd Kinsey – At the Library, create a hungry caterpillar of your own—just like the famous one Eric Carle wrote about! This craft program will take place on Wednesday, February 27 from 10:15 until 11:15 in the Library Theater and is for children from 0 to 5 years old and their families. Learn about how the personal collection of J.P. Bryan became the Bryan Museum in Galveston. This program is for adults and is part of the History Club series of programs. It takes place on Thursday, February 28 from 7 to 8 p.m. in the Library Theater. Teens, come be a part of the Teen Book Club Monday, March 11 from 5 to 6 p.m. in the Library Theater. We'll be talking about books with a robotics theme, and it can be any book having to do with that topic that you feel like sharing. This program is for 6th to 12th graders.

Larry Millican – Welcome everybody. I'd like to thank everybody for coming tonight, and welcome the folks tuning in on Channel 16 and online. I'd like to report on some of the actions taken by H-GAC Transportation Policy Council at the meeting last week. The TPC passed a resolution supporting Highway 99. They passed that resolution for Segment B in Galveston and Brazoria Counties. The resolution asked TxDOT to complete all the traffic and revenue studies as quickly as possible and should the counties relinquish any primacy, proceed as quickly as possible to the final right-of-way and design and construction of the roadway. The TPC approved a resolution on additional funding for the Landing bridge and roadway, the extension of Landing. This is a \$27 million change order that's split 50/50 with the City of League City, the sponsoring city in the state of Texas. The change is for the realignment of the roadway and the subsequent relocation of the bridge span over Clear Creek. The length of the bridge increased from 700 feet to 2777 feet. That's a tremendous change, and to go into it a little bit more, the change is actually to the span length, it requires a structural change and an upgrade to steel from the concrete that was originally built. This change was largely due because of the fact that realignment of the creek and the elimination of those pillars in the creek so that the flow of water will be much greater underneath a 2700 foot span than a 700 foot span. It was mainly due to the realignment and also the ability for the roadway to travel at faster speeds. The construction is programmed now to begin in 2021 with the change order.

The Policy Council also received a briefing on the amendments to the TIP for next month's meeting, which includes one of the changes it's good to know it's going to be Webster's portion of the Landing extension and it's going to be on the agenda to approve their portion and their change order for the going over of the creek up there on the north end of that roadway. Again, with the entire completion of that it looks like that project is set to go and begin somewhere about 2021. I also put a copy of the presentation that we received from the High Capacity Transit Task Force at everybody's seat on Council tonight. I found it very interesting and very enlightening and thought-provoking, the study considers where we are today and where we'll be in 2045 as for transit. And this is going to be mass transit, not just roadways, but mass transit. They're predicting 2045 to increase the population of the eight counties that we serve by a total of 4.2 million people. If you think about that, right now we're the fourth largest city in the nation with a little bit more than 4 million people. And in 2045 we're going to be even increasing that double. What this means to high capacity transit and what's it going to look like. How's it going to be funded? It's a very intriguing part that needs to be discussed, what we want to consider the first mile and the last mile. It's concerning for League City. League City currently has no transit, no mass transit, no consolidated bus routes, or anything like that. Considering that, let me say it's not that I think that this city wants to have any of those mass transportation. But when you look at the plan itself and when you identify the corridors that are going to need mass transportation, maybe high speed rail, maybe elevated rail, there's a lot of scenarios in that package I gave you. But, where does the City need to be to keep that small town feel? Where does the City need to be involved in some of the activities and for matter where do transit centers need to be? If this city is going to grow, and we're going to grow again twice the size that we are, we've got that in all of our water use plans, our transit plans, our transportation plans, our housing plans, our water needs, I mean we are all figuring that's where it's going to be, start puzzling and say well where is the transit center itself going to be that's going to connect us to the rest of the world. We can't be just isolated, we've got to consider how we're going to connect, and where those transit centers need to be and what they need to look like. I think the Mayor says it best when he said he attended one conference that talked in terms of autonomous vehicles. They're now discussing autonomous buses and how that's going to look and how that's going to play in. Where do those fixtures leave League City, where do we figure into this plan? How do we get our citizens mobile around this whole area? I think it's good to ponder those ideas, think about them and that's the reason why I thought you all would enjoy reading about getting to it.

Greg Gripon – Councilman Millican did leave one thing out, both of us will be leaving out tomorrow to San Marcos for TML Elected Officials Conference. It'll be a two-day event, look forward to it. Hopefully the weather's going to dry up. I heard somebody pose that our mud is getting rehydrated and it needed to dry up a little.

Chad Tressler had no comments.

Hank Dugie – I am happy to announce that this weekend I traveled to Arlington and competed in the Southwest Regional Quidditch Championship, where my team took third place. It's not first place but we're satisfied because it allows us to go to Round Rock in April and compete for a national championship. I'm even more happy to announce that students from League City were represented on twelve different teams at the tournament, so it made be an odd and quirky recreational activity that we do here in League City, but it's really allowing these people to travel, engage in new friendships and relationships and to participate in something that's fun and also keeps them active and healthy. So, in May we will be have tryouts for the League City Legends major league Quidditch team. I am expecting to be the coach of the team once again and for anyone out in the audience that'd like to play, especially you high school students that are graduating, be looking out for announcements in the near future. I would also like to thank all the high school students that are still here for participating in the student government day. I was elected to Council at the age of 26, so that means you all have 8 or 9 years to get elected to this Council. We're all excited to have you up here. A lot of people ask me how do you get involved and I tell them the first step really is just showing up, just be present and you'll find something that you're passionate about and an opportunity will present itself and you can take it. So just show up and that goes for anything in life. No matter where you go if you want to be successful, you want to do good, just show up and opportunities will present themselves. Thank you for showing up and be a part of this today. Good luck to you wherever you go.

8A. <u>19-0127</u> Presentation of the League City Police Department's Annual Racial Profiling Report for CY2018 (Chief of Police)

The report was presented by Chief of Police Gary Ratliff.

City Manager John Baumgartner – This Saturday is League City's first household hazardous waste day, I believe it's from 9:00 am to 2:00 pm at Hometown Heroes Park. It is being paid for by the citizens of League City, being run by AmeriWaste, and as such we are going to require ID and water utility bill to prove League City residency. It is an expensive event to run and it's not county-wide, there's not a grant for it like there has been in the past years so just for our use. Again, that event is Saturday, 9:00 to 2:00 at Hometown Heroes.

The other thing I that we're all waiting anxiously for is TxDOT is going the remove the overpass at 646. I believe that starts Friday night, or Saturday. So we will see traffic patterns change throughout the community. With some luck and good weather that should be done in about six months. Meanwhile, plan a little extra time, if you can avoid the frontage roads, Walker, Calder Road, you'll see additional traffic out there as people try to get back and forth from the highway. Just a quick comment on League City Parkway. Ms. Turski is correct, that's not currently in our approved CIP. It is certainly on our minds as to how we're going to get it paid for. I've had a couple of conversations with Commissioner Clark related to the Galveston County bond program, perhaps there's some discretionary money that can be assigned to that. We're balancing the need to complete that section of League City Parkway with the need to complete the section to our city limit line. Both of them are of interest, there's probably not enough money to do both, and then the other alternative is to perhaps extend the TIRZ that exists. The TIRZ is how Westwood funded the completion of Maple Leaf and the extension of League City Parkway, so I'm looking at that as a possibility in working with the Westwood TIRZ as well as Commissioner Clark and hopefully by budget time we'll have some sort of vision on how we move forward with that. Meanwhile, Ms. Turski is correct. It's not part of our CIP as we sit here today.
