Announcements concerning items of community interest. No action will be taken or discussed.

Mayor Pro Tem Todd Kinsey - Last week I went to the grand opening of UTMB's new facility, Clear Lake. They've done a really nice job remodeling that facility and rebranding it. If you drive through Clear Lake you'll see it, it's got a big red stripe around the top now and really stands out when you drive through the area. They've really done an amazing job refitting that facility and I try to do as much of my stuff here in League City, but I've been to that facility before and will probably end up there again. It's definitely state of the art. At the Library, Assistant Chief James Spencer of the League City PD will speak on the role of the police department in the community. He will come as part of the Thursday Talks program series on Thursday, March 28 from 10:15 to 11:30 a.m. in the Library Theater. This program is for adults and their families. Come watch the movie The Secret of Kells on Saturday, March 30 and enjoy some popcorn. This program is part of the Saturday Special program series and will be held in the Library Theater from 4:00 to 6:00 p.m. This program is for all ages. Children must be accompanied by a parent or guardian. Join us for an afternoon of crafting on Saturday, April 6, from 3:30 to 5:00 p.m. in the Library Theater. We will create a fun springtime paper décor craft. This program is sponsored by Tyler Landry State Farm and is for adults. Chad Tressler had no comments.

Nick Long - I'd like to thank the Mayor for nominating me to H-GAC Regional Flood Control Management Council. The nomination has been accepted, the first meeting is April 17. I plan on fighting to get as much money down League City's, southern Harris and Galveston County as possible and will report back.

Andy Mann had no comments.

Hank Dugie - First, I'd like to thank everyone for being here and for tuning in at home. I know you could be doing other things and spending it here with us means a lot. I am happy to report that we still live in the greatest city in the greatest country on earth, and you make it so. We are almost two years out from Hurricane Harvey and there are still people that are recovering, getting their lives back together and they're still being helped by their neighbors. A lot of those people providing the help and the aid are you, or friends, or loved ones. Last week the Mayor was kind enough to sign off on a certificate of recognition to a group of students from Iowa State University. 36 of them came down to League City over their spring break and they worked on eight different homes in the area that had been affected from Harvey and still had not been completely put back together. Just a little perspective, there are people still hurting from that event, as well as from other events, and what makes League City great is the people that are willing to put the time and effort into helping one another. So keep up the good work. We'll continue to do our part up here, but it really truly is a team effort. I don't have any new news from the Dickinson Bayou Watershed Steering Committee. We did not meet this month, but we will be meeting next month and we're going to have to get a bigger room soon because we have a lot of people from the public attending, a lot of interest. I'm happy to hear that Mr. Long's on H-GAC finding us money because we're going to come up with some projects that are going to need some money, so I'll bring you the projects and you bring me the money, Mr. Long.

Larry Millican - Welcome, everybody for coming and welcome everybody at home on Channel 16 or Skyping in or online, or however you do that. Me being technologically challenged, I really don't know that. At your positions I left two documents. One is going to be autonomous vehicles and driving and I got that at H-GAC at the Policy Council meeting and I thought it was a good read. Also, an alert is that we have a special Policy Council Meeting April 4 at the Texas Department of Transportation that they're going to unveil their 2045 Plan. They have gotten through all of their public comment period and put together their plan and they're going to break it out and that's going to be at a special meeting on April 4. The second package that I put at your desk is going to be what the Policy Council approved to go to the board of directors for the new TIP, the 10-Year TIP. These are all the projects that were submitted for $\$ 33$ billion worth of money. Some $\$ 300$ billion worth of projects were submitted and we submitted one project from League City and it was rejected. So, out of all of the money for the next 10 years coming out of the TIP, we don't have anything that we put in there for.

The entire list is there, what was approved, what wasn't, but it's highlighted so that you all can look through it and at that point we can discuss it later. One other thing, Saturday morning is going to be the opening of spring turkey season and I bring that to everybody's attention because I will not be in town, I will be spring turkey hunting. But more importantly, on Sunday, is my 47th wedding anniversary.

Greg Gripon - Good evening. What a beautiful Chamber of Commerce day we had today! This is some wonderful weather we're having. About a month away from now is the League City Village Fair and Music Festival, four days this year Thursday through Sunday. Our next Council Meeting we're going to actually have a presentation here telling you all about it, but if you want to learn more, go to levillagefair.com and you can find out all about it. Or pick up one of the push cards at the entrance.

Mayor Hallisey - A lot of things happening around town, I just want to remind you that Mondays at 12:30 is "Mondays with Mayor Pat". You can call in, it's Facebook live. We talked a lot last week about the upcoming bond issue and some of the details of that and we will continue along those lines, plus other things that are of interest to all of you. Friday morning, one of the fun things I get to do is go out to all these schools, and I showed up at Calder Road Elementary. I spoke to all the first graders, I can tell you I didn't dazzle them with my brilliance, but they all wanted to know where my leg went. I couldn't believe they were that observant. I, of course, explained to them, sort of explained to them, how I got to that situation. But I tell them, like I do all first and second graders, I lost it and if they can find it I have a crispy five-dollar bill that I will be willing to give them. Saturday was Bayside Little League opening parade in Baytown. Mr. Tressler and I were there for opening ceremonies. There was a parade and we were judging the parade and I was sitting there, hadn't seen Mr. Tressler and he bopped up behind me and I could hear this whisper behind my head, said just in case you didn't know, that float in front of you has my children on it and they're all from League City. I said not a problem, I'll give them a point difference. When you look out everybody, pretty much, from east of 270 plays in Bayside Little League, which takes in Kemah, Seabrook, El Lago, and over that side of the lake. You see parents and kids out there just all excited. You can't help but think that anything we do that puts families to work together is not a bad deal. It was exciting. I left there at about 10:00 and came zooming over to League City because League City Little League had their opening day out at the Chester Davis Sportsplex. I was fortunate enough to be there, they asked me to throw out the first pitch and I have to tell you what a year's difference it's been. Last year I rared back in my wheelchair and I fired that ball down and I don't think I had a strike, but I was within the box. I was very proud of that, that I could make it all the way down to Homeplate. This year, I was way out of the box to the left side and the poor catcher had to do some reaching to get out there to get it. I guess I need to practice more. There were 1,000 kids out on that field and it's just comforting to me and encouraging to see families doing things together. It is the nature of keeping that family unit together. Anyway, it was an exciting day.

Saturday night I ended up at the Lighthouse Christian Ministries. They had a fundraiser at Ellington at the Airplane Museum. There were probably another $\mathbf{1 , 0 0 0}$ people at that deal, and they were pouring out a lot of money. Lighthouse Christian charities does a lot in our community and in fact the entire Clear Lake area, helping those who are not as fortunate as a lot of us. Sometimes we have to remember that's part of our responsibility, trying to help where we can. But it was a great event. Then Sunday evening I was fortunate enough to be invited to a small dinner party for the Ambassador to Greece and he was a delightful fellow and his wife was charming. While I was there, Scott, I got another card for you. I did not know we had three shipping companies that headquarter out of League City. The company that put on the dinner for the ambassador is called Oceanus. They're out in One Harbour Square on Marina Bay Drive. They had a lot of their people there, and they kept talking about the United States, according to these guys, is about to become the biggest exporter of petroleum in the world. And they're talking about all the things that are happening out in the Permian Basin. So in that discussion, was League City really could be the shipping capital of the Gulf Coast and I kept saying, but we don't have any water for the ships to pull into, but it doesn't appear to be the most important thing. They're all going to Houston, Galveston, Texas City, and down to Freeport. Which brings us to the point of the Grand Parkway. We are also hearing the Grand Parkway is moving forward, maybe five years of so before we see it, parts of it getting done, but the Governor and Lt. Governor have loosened up their strangle-hold on toll roads, which is a great deal for us because $65 \%$ of our working population goes to the northwest corner of Harris County. We're very excited about that, and of course, all of you know that 146 is being expanded to be a high-speed thoroughfare up to the Fred Hartman Bridge. It will also be part of State Highway 99 which is the Grand Parkway. Exciting things are happening, of course, one of the things I said Monday, the next major hurricane that comes into the Gulf that bears down on League City, we now hopefully, in the future will have an eastern escape route up 146, up east Texas and will also have an escape route to the west on the Grand Parkway and hopefully, we will get out of here before we have anything that looks like a Harvey that comes back to see us. Good things are happening, there is a bond issue on our agenda for May 4. I certainly want to encourage everybody in town, be an educated voter. This is your community, you're going to get an opportunity to make a decision on what the City's going to look like in the next 25, 30, 40, 50 years. Drainage is a major issue, John had a study done last year and transportation was the number one issue, even above drainage and that was after Harvey. Those two are on there. We have not had the best luck in years past with an economic development sales tax. We have changed our tone this year, it will not be an economic development sales tax, it will just be a straight sales tax, and of course, there's a lot of concern out there. Well, what happens after you pay these bonds off, are you just going to have another slush fund at City Hall? I keep telling people, over and over, that is not going to happen. The ballot language is pretty specific, we're not going to be able to change our mind after it passes. Please go to leaguecity.com, Sarah Greer Osborne has done a great job of getting all the information, all the details of what projects are up for funding.

And let me say one thing about Palomino because there's a lot of people that ask questions about it. We looked at Palomino, there was a lot of support for Palomino, but Palomino goes nowhere south. We are trying to get roads that will go down and meet the Grand Parkway and go past that to 517 and that's what you're going to see in the bond issue. If we can't get you to a major thoroughfare quickly to get to the work centers, then we're just kind of waving our gums in the breeze. So when we looked at the Landing, it went all the way down to 517, it will go to 517, it will go to the Grand Parkway and it will connect to the north of NASA Road 1. I think John and his staff did an exceptionally good job of getting this issue to where it made sense to people who live here and if it doesn't make sense to you, we've had five public hearings which we're going to continue to have. We have Mondays with Mayor Pat you can call in, and listen up on Facebook because every one of these Council Members is signing up to do their time. How many of you are on board for the deal? Everybody's on board. This is a group effort. We can't do it alone, certainly can't do it without all of you that are here tonight and all of you that are at home listening to this. This is our opportunity to jump start our travel to the future, no pun intended. Read up on it, it's on the website leaguecity.com or call Sarah Greer Osborne, she knows everything about everything. She was a good acquisition from the Houston School District, I can tell you.

City Manager John Baumgartner - I just want to remind the Council and the community that the new utility billing software has gone online. Obviously it creates a few little challenges, some benefits are we get a bill in a sealed envelope rather than a postcard. Those with e-billing and auto-pay will need to wait for their first email. They'll have to re-sign up for auto-pay, a little bit of an inconvenience because everybody will get a new account number and a new customer identification number, CID number. You need those numbers so that you can sign up for auto-pay again and everybody that wants that will have to re-sign up unfortunately. Communications and Utility Billing are working together to alert customers about the new billing software and changes it brings with it. Citizens University, I think we're going on class, Sarah is on her one-year anniversary, so the fifth class. The last day to sign up is Friday, March 29. It starts the first week in April, it meets Thursday nights at 6:30 p.m. We have fliers in the back of the room for those who want to sign up, or you can go to leaguecity.com for more information.
