Larry Millican – I passed out to everybody this evening, something that I picked up at H-GAC and had it on the dais when you came in. It was something that really impressed me, not so much because of the statistics for the safety report itself, but that was interesting. I'd like for you all to look at it, but the interactive web applications and what you can do with it, I can tell you that this city will benefit greatly from that if we get in and use it. You yourselves will find it enlightening if you get in and start selecting and drill down to what it is that you'd like to look at. We'll be able to use it in economic development, we'll be able look at it as far as traffic, as far as neighborhoods. It's just really great, I can't tell you how impressive the demonstration was at H-GAC. I wish I would have been able to have an application up for you tonight, but spend some time and look at it because it was impressive to me.

Chad Tressler – If you're here tonight or watching from home, I thank you for your dedication.

Mayor Hallisey – I've been busy the last couple of weeks and I'll share it with you. First of all, I'd like to call up Officer Christy Galyean, Officer Todd Young, Sgt. Robert McCurley, Sgt. Chris Skendziel, Officer Trevor Rector. Silvio Vincenzo and Nancy Leon, are they here? We pay these ladies and gentlemen to protect us out on the streets of League City. Being a first responder, we know isn't just protecting people on the streets. It's protecting people, period. These folks have donated their time, not the City's time, their personal time for a program called "Bigs N Blue". They work as mentors to the students at League City Elementary School. We don't have an award for that, but I want to say just how absolutely proud I am that you guys go over there. League City Elementary is an interesting set of demographics over there and there are children over there that need every bit of attention that they can get. These officers are providing that for them. I want everybody in TV land to look at them so when you see them on the street, or you see them in the store, just say thank you for your service because we all up here are very proud of what you're doing. Thank you. A lot of hullaballoo this week, and I talked about the pink gazebo, so you know that's going to come back to being white at the end of the month. I want to acknowledge, all of you watched on TV, as Harris County Sheriff's Deputy Sandeep Dhaliwal was laid to rest. He was also, as I said last meeting, instrumental in bringing supplies down to League City during our turmoil during Hurricane Harvey and he was remembered by a lot of folks in this community for having a big heart. We want his family to know that we appreciate his service and that he will be remembered in our community for a long time. Christy Galyean left, but I went to a National Night Out with her and Silvio Vincenzo the other night, had an absolute blast seeing people. I went into the Historic District, had a great time visiting with those people about what's going on in town. I went out to the Villages of Tuscan Lakes, which is a 55+ neighborhood. They had probably close to 200 people in their clubroom. It was the epitome of what National Night Out ought to be. They were all eating ice cream and having a grand time and it was fun. If any of the rest of you made it out there, you know exactly what I'm talking about. Anchor Point fundraiser, several of us were at a week ago. Anchor Point changes lives in young people, young people that have gone astray. There were a good 400-500 people out there donating their time and their money, so I was proud to be there. BAHEP Mayor's Round Table has been meeting. We had a September public meeting on clearing of the Clear Creek tributaries last week, which was interesting. Kudos go to Christopher Sims, our Engineer, who stood up in front of that entire crowd and gave a great presentation for about 40 minutes. He did a super job. Larry (Millican) and I attended the Florence Campbell Elementary School dedication, which is brand new CCISD elementary school in Westwood, which is on the far reaches of League City. I think somebody said it was their 27th elementary school, which really speaks for a fact that we are growing in this area.

Amber, who was here earlier talking about motel/hotel tax took me over to St. Mary Catholic School where I met with kindergarteners and first-graders. You can tell them anything and they're just as happy to see you. It's nice to see smiling, happy faces wherever you go. The following day, Amy Killgore and I greeted all the elementary school kids at Bauerschlag Elementary. We sat in the parking lot and told them we were glad they were there, hoped they were all making A's, if they weren't keep plugging at it. The future of this world is vested in the children. CCISD does a great job. It never hurts to give them a slap on the back and show an interest in them. Had a great time. Upcoming items – this Sunday, October 11 at 6:00 p.m., that's this Friday, is the Italian Heritage Festival Dinner at Butler Longhorn Museum. If you have not gotten tickets, please come. The Italians were a big part of the settlement of this community in the 1880's. Sunday, October 20, the Rotary Club of League City and Friendswood will be having a "Rotary Regatta" race for canoes and kayaks on Clear Creek from the 1776 Park in Friendswood to Lynn Gripon Countryside Park in League City. I went last year, fascinating. Some of those big kayaks will scoot and the canoes are just a bundle of laughs because people fall out of them, they're not good at steering them. October 24 is the Candlelight Vigil for Domestic Violence Awareness at our Public Safety Building across the street. Usually have a good turnout. Several of us, I think Larry and Chad and John and Mr. Long are headed out tomorrow morning bright and early for the Texas Municipal League Conference in San Antonio. And Greg Gripon. We're going to TML to try to learn how to do this better and I'm trying to get better at reading it all. Anyway, it has been an eventful two weeks and this community continues to grow, continues to prosper and we have a long agenda still to go.
